A PROCLAMATION.

WHEREAS the General Assembly of this Province stands prorogued to Thursday the twentieth day of December instant, I have thought fit further to prorogue the said General Assembly, and the same is hereby prorogued accordingly to Thursday the thirty first day of January next.

Given under my Hand and Seal at Fredericton, the seventeenth day of December, in the year of our Lord one thousand eight hundred and sixty six, and in the thirtieth year of Her Majesty's Reign.

L. S.] AT THE COURT AT WINDSOR, The 10th day of November, 1866.

PRESENT:

The QUEEN'S Most Excellent Majesty,

Lord President, Lord Chamberlain, Earl of Derby, Mr. Secretary Walpole.

WHEREAS the Lieutenant Governor of Her Majesty's Province of New Brunswick, with the Council and Assembly of the said Province, did in the month of June, 1865, pass an Act, which has been transmitted, entitled as follows, viz:—

No. 3067. An Act to incorporate the Woodstock Bank.

And whereas the said Act has been laid before Her Majesty in Council, together with a Letter to the Lord President of the Council, from the Right Honorable the Earl of Carnarvon, one of Her Majesty's Principal Secretaries of State, recommending that the said Act should be left to its operation; Her Majesty was thereupou this day pleased, by and with the advice of Her Privy Council, to approve the said recommendation: Whereof the Governor, Lieutenant Governor, or Commander in Chief, for the time being, of Her Majesty's Province of New Brunswick, and all other persons whom it may concern, are to take notice, and govern themselves accordingly.

## NOTICE.

It having come to the knowledge of His Excellency the Administrator of the Government, that in some instances persons have assumed to themselves the position of Consular Agents in New Brunswick for Foreign Powers without sufficient authority for so doing, His Excellency directs it to be made known, with a view to prevent future inconvenience or disappointment, that he is not at liberty to recognize in an official capacity any person as Consul, Vice Consul, or Consular Agent for any Foreign Power, unless the appointment has previously received Her Majesty's sanction.

A notification of an appointment having been so approved, and of the "Exequatur" having received the Queen's signature, will always appear in the "Royal Gazette."

Sir,—I have the honor to transmit to you, for your information, the accompanying copy of an Order in Council, extending to the subjects of the Kings of Siam the provisions of the Foreign Deserters' Act, 1852.

The QUEEN'S Most Excellent Majesty in Council.

WHEREAS by the "Foreign Deserters' Act, 1852," it is provided, that whenever it is made to appear to Her Majesty that due facilities are or will be given for recovering or apprehending seamen who desert from British merchant ships in the territories of any Foreign Power, Her Majesty may, by Order in Council, stating that such facilities are or will be given, declare that seamen, not being slaves, who desert from merchant ships belonging to such Powers, when within Her Majesty's dominions, shall be liable to be apprehended and carried on board their respective ships, and may limit the operation of such Order, and may render the operation thereof subject to such conditions and qualifications, if any, as may be deemed expedient; and whereas it has been made to appear to Her Majesty, that due facilities are given for recovering and apprehending seamen who desert from British merchant ships in the territories of their Majesties the Kings of Siam;

Now, therefore, Her Majesty, by virtue of the powers vested in Her by the said "Foreign Deserters' Act, 1852," and by and with the advice of Her Privy Council, is pleased to order and declare, and it is hereby ordered and declared, that, from and after the publication hereof in the London Gazette, seamen, not being slaves, who, within Her Majesty's dominions, desert from merchant ships belonging to the Kingdom of Siam, shall be liable to be apprehended and carried on board their respective ships:

Provided always, that if any such deserter has committed any crime in Her Majesty's dominions he may be detained until he has been tried by a competent Court, and until his sentence (if any) has been fully carried into effect.

And the Lords Commissioners of Her Majesty's Treasury, the Right Honorable the Earl of Carnarvon, the Right Honorable Viscount Cranbourne, and the Right Honorable Spencer Horatio Walpole, three of Her Majesty's Principal Secretaries of State, are to give the necessary directions herein accordingly.
