Lieutenant Governon 18 oraere I in Council, that the Inland Postage on Books and Pamphlets in New Brunswick be reduced from one cent to onehalf cent per ounce; also to collect one-half cent per ounce Major :-on Pamphlets received in Mails from the United Kingdom, when prepaid as Newspapers, and shall be taxed according to rates of four ounces each; one rate of four ounces, two cents ; exceeding one rate, up to eight ounces, four cents ; !

exceeding two rates, up to twelve ounces, six cents ; and so on, adding two cents for every rate or fractional part thereof. To be applicable to the United Kingdom and the Provinces only.

PROPOSITION has been made by the Postal Autho-rities of Canada to extend the limit of Money Orders with New Brunswick interchanging with Canada, from £10 to £20 Sterling, to have effect from the 1st January, 1867, and that the Scale of Money Orders between Canada and New Brunswick shall be as follows :----

One Shilling Stg. On Orders up to £5 Sterling, On Orders over £5 and not exceeding £10, Two Shillings " On Orders over £10 and not exceeding £15, Three Shillings "

On Orders over £15 and not exceeding £30, Four Shillings " Proposition approved by His Excellency in Council this 92th day of November, 1866.
