John Mullen, 26 years of age, 5 feet 7 inches in height, complexion dark, face full, eyes dark gray and full, hair and beard black, left arm a little crooked, been broken, stiff, blue cross marked on right arm, blue ring on finger of left hand, hesitates in speaking.

James Gilmour, about thirty years of age, 5 feet 8 inches in height, swarthy, eyes gray, hair dark, beard sandy brown, scar lower part right cheek, two inches long and one and a half wide, a rough ill-looking fellow.
