I have therefore thought fit to declare, and I do hereby declare, that the following articles, being of the growth, pro-duction or manufacture of the British North American Possessions of Canada, Nova Scotia, Prince Edward Island, and Newfoundland, or of either of them, may be imported into this Province free of Duty, that is to say :---

Pork and Beef, salted and fresh ; Hams, smoked or dried ; Rock or Coal Oil, Benzole, and Parafine ; Horses, Mares, Geldings, and Oxen, Neat Cattle, Cows, and other Cattle ; Hogs alive, and Sheep.

Given under my Hand and Seal at Fredericton, the first day of August, in the year of our Lord one thousand eight hundred and sixty six, and in the thirtieth year of Her Majesty's Reign.
