GOVERNMENT NOTICE.

HIS Excellency the Administrator of the Government in Council, has been pleased to make the following Orders, viz:—

That the present Close Fishery District, Letter A, be abolished, and that the following comprise the District:—

Letter A—All that part of the South West Branch of Miramichi River, from the upper end of Beaubear's Island, and to extend up the River to the lower or easterly side line of the Lot presently occupied by Stephen Mitchell, in the Parish of Blissfield;—And further ordered, that Christopher Parker be appointed Fishery Warden for the said District Letter A, in the room of John Jardine, left the place.

That Nos. 3 and 4 of the General Regulations for the protection of the Fisheries in this Province, passed in the 26th year of the Reign of Her present Majesty, be and the same are hereby revoked; and in lieu thereof, the following Regulations are made, viz:—

Every person who shall wilfully injure the young of Salmon, or take or carry away any of the spawn thereof, or disturb any spawning bed or any bank or shallow on which the spawn may be, or who shall throw any lime, chemical, or drug, into any Stream or River, whereby the fish or spawn of fish may be injured, shall for each offence pay a fine of forty dollars, or be imprisoned for twenty days:

Every person who shall wilfully disturb or attempt to catch or kill Salmon during the spawning season, or while on the spawning beds, shall for each offence pay a fine of forty dollars, or be imprisoned for twenty days:

That it shall be lawful hereafter to set nets for the catch of Bass on the Flats in the River Bartibog, in the County of Northumberland, from the mouth to the head of the tide, either on floats or pickets, from the first of September in each year, to the close of the navigation; provided that such nets be of not less than five inch mesh, under a penalty of twenty dollars for each offence.

ORDERED, That New Bandon, County of Gloucester, be appointed a Port of Entry for the admission of Foreign as well as British and Colonial Shipping and Goods.
