

Candidate who shall come out highest at that Examination, provided that he pass either in the Honours or in the First Division.

6. The award of the Examiners shall be transmitted forthwith by the Secretary of the Gilchrist Trust, through the Colonial Office, to the Local Authorities in the Colonial Capitals, to be by them announced to the Candidates.

7. The successful Candidate will be expected to arrive in London, and to present himself to the Secretary of the Gilchrist Trust, not later than the first week in the October following his appointment.

8. Each Scholar shall be allowed an option as to place of study between the University of Edinburgh, and University College, London; but he shall be expected to pursue his studies with a view to Graduation in one of the Four Faculties of the University of London.

9. Each Scholarship shall be considered as commencing from the 1st of July following the award of the Examiners; and shall be paid in quarterly instalments on the first days of October, January, April, and July.

10. Each Scholar shall attend in every Session at least Three Courses of Lectures at the Institution in which he studies, and shall transmit to the Secretary of the Gilchrist Trust, at the conclusion of each Session, a Certificate from each of the Professors whose Lectures he has attended, stating that his diligence and conduct have been satisfactory. Should he not be able to produce such a Certificate, or should he be proved guilty of discreditable conduct elsewhere, he shall be considered to have forfeited all claim to the remaining instalments of his Scholarship.

11. Each Scholar will be expected to present himself at the First Examination in one of the Four Faculties of the University of London—Arts, Science, Law, or Medicine—before the termination of the Second (Academical) Year* from the commencement of his Scholarship, unless excused from doing so by the Trustees; and if he do not so present himself, (unless by permission of the Trustees), or if he fail to pass, he shall be considered as forfeiting his claim to the remaining instalments of his Scholarship. After having passed the First Examination, he will be expected to pursue his studies with a view to presenting himself at the Second Examination within two (Academical) years.

12. The foregoing Scheme shall be subject to revision from time to time; the Trustees reserving to themselves the power of altering the conditions of the Scholarships, or of altogether withdrawing them, if they deem it expedient to do either. But no change will be made in such a manner as to affect the interests of Candidates already appointed to Scholarships, or in any case, without Twelve Months' Notice.

* Thus a Candidate whose Scholarship commences on the 1st of July, 1868, would be considered as having fulfilled this condition, if he pass the First LL.B. Examination in January, 1870; or the First B.A., the First B.Sc., or the Preliminary Scientific M.B. Examination, in July, 1870.

MAY IT PLEASE YOUR EXCELLENCY,

We, the Mayor, Aldermen and Commonalty of the City of Fredericton, in Council convened, on our own and the citizens' behalf, beg to tender to Your Excellency the expression of our unfeigned regret at Your Excellency's departure from among us.

We beg to convey to Your Excellency the assurance, that during the short time it has been permitted us to recognize you as Administrator of the Government and Lieutenant Governor of this Province, your every act has shewn Your Excellency a worthy and able representative of our beloved and gracious Queen, and that in your person, as such representative, royalty has lost none of its ancient glory.

The acts of kindness and urbanity by Your Excellency to all the citizens, without distinction, on various occasions, accorded with the true spirit of a British gentleman and soldier, will, we assure Your Excellency, never be forgotten.

The deep interest Your Excellency has always evinced in all that concerned the best interests of this City, justly merits our warmest acknowledgments and sincere gratitude.

We rejoice to assure Your Excellency that amidst the long line of Governors of this Province, who have received direct from the hands of Britain's Sovereign the commission to rule over us, none have exercised the power committed to their trust with greater impartiality than Your Excellency, being the last Lieutenant Governor who has received or will hereafter receive a commission as Lieutenant Governor of this Province from such high authority. We rejoice to know that Your Excellency

will return to our beloved Sovereign, untarnished, the sword by her committed to your trust, tempered as your every act of justice has been with that mercy which is the brightest jewel in the diadem of England's monarch.

Permit us again to assure Your Excellency of our sorrow at your departure, and to convey to Your Excellency our cordial desires that your life may long be spared, and that your future, as the past, may be crowned with honor; and should Your Excellency again visit this, the metropolitan City of New Brunswick, officially or otherwise, your greeting from all its inhabitants will be as hearty and honest as our and their regret at your departure is sincere.
