## ALTERATION OF LIGHT ON GANNET ROCK.

The Colonial Government of New Brunswick has given Notice, that the following alteration will take place in the flashing light exhibited from Gannet Rock at the entrance of the Bay of Fundy.

The present light will be discontinued from the 9th day of July 1867, and no light will be exhibited until the 1st day of August 1867, when a new light will be substituted.

The new light will be a fixed and flashing white light, showing in every minute a steady white light for forty five seconds, followed by an eclipse, a flash and another eclipse, each of about five seconds duration.

The illuminating apparatus is dioptric or by lenses, of the fourth order.

UNITED STATES-RHODE ISLAND.

FOG SIGNAL AT POINT JUDITH LIGHTHOUSE.

The United States Government has given Notice, that from the 1st day of June 1867, a trumpet blown by machinery will be in operation in foggy weather at the Lighthouse on Point Judith.

The apparatus is arranged to give a blast of four seconds duration, at intervals of twenty four seconds.
