GULF OF ST. LAWRENCE.

FIXED LIGHT IN GASPE BAY.

The Trinity House at Quebec has given Notice, that during the season the navigation is open, a Light will be exhibited on the Peninsula on Gaspe Bay, 12 miles N.W. by

# BYE LAWS.

### ARTICLE 1.—ELECTION OF OFFICERS.

The election of the Council of the Association, and of all Officers chosen or appointed by the Council, shall be by ballot, upon nomination duly made and seconded; and no vote shall count for any person not so nominated.

#### ARTICLE 2.—ANNUAL MEETING.

At least fourteen days' notice of the place appointed by the Council, for the annual meeting of the Association, shall be given by the Secretary by advertisement in the Royal Gazette.

ARTICLE 3.-MEETINGS OF COUNCIL

1. The regular quarterly meetings of the Council shall be held

3. Notice of the time and place of every quarterly and special meeting of the Council, shall be issued by the Secretary to each member, at least ten days before the day appointed for the meeting.
4. Meetings of the Council may be adjourned from day to

day, as may be found recessary.

5. If at any quarterly or special meeting of the Council, a quorum be not present, three members of the Council, (an Officer of the Association being one), shall have power, after waiting half an hour, to adjourn the meeting to another time; and it shall not be necessary to issue notices for such adjourned meeting.

ARTICLE 4.—COMPETITIONS.

1. The annual meeting, to compete for the Prizes offered by the Association, shall be held at such time and place, during the first week in September in each year, as the Council may
