ARTICLE 5.—REGULATIONS FOR COMPETITIONS.

1. An Umpire shall be appointed by the Council; all disputed points shall be decided by the Umpire, whose decision shall be final.

2. An Officer shall be appointed by the Commander in Chief, to take command of all who may assemble to compete for the prizes, and to maintain order and discipline on the field.

3. There shall be five ranges, namely, of 200, 300, 400, 500,

and 600 yards.

4. The size of the Targets to be used, shall be the same as laid down in the Army Musketry Regulations, viz :-

200 and 300 yards, 2 Targets, 4 ⋈ 6 feet. Bulls-eye, 2 ⋈ 1 "

Centre, 4 × 2 "

400, 500 and 600 yards, 3 Targets, 6 × 6 " Bulls-eye, 2 ⋈ 2 " Centre, 4 ⋈ 4 " Centre,

Bulls-eyes to count 4; Centres, 3; Outers, 2.

5. The shooting at 200 and 300 yards to be off the shoulder; at the remaining three ranges, it shall be from the knee, Hythe position, unless off the shoulder.

6. No magnifying sights, fixed artificial rests, or hair triggers, shall be allowed at any competition, nor shall any competitor place any leather or other substance in front of the trigger, in order to lessen the pull thereof; any competitor offending against this Bye Law shall forfeit any prize he may have won, and be disqualified for competing again during the meeting.

7. In shooting for prizes the minimum pull of trigger shall not

be less than six pounds.

8. Competitors shall, if required, submit their Rifles for inspection before, during, or after firing.
9. Ties:—1. Where prizes are competed for at one range only, ties shall fire one shot each at that range until the best shot be returned:-2. Where prizes are competed for at more than one range, ties shall fire one shot at the longest range, until the best shot be returned.

10. Government Rifles and Ammunition shall be used. Any competitor infringing this Rule shall be disqualified from competing for any prizes during the remainder of the meeting.

11. Any competitor discharging his Rifle without having previously obtained permission from the Officer in command of the field, or from the Squad Commander, shall be fined two dollars, and in default of payment, or if, under the circumstances, the Officer in command of the field shall so decide, be disqualified for competing for any prizes during the remainder of the meet-

12. Competitors are not allowed to change their squad through-

out the meeting after having been once placed.

13. Competitors allowed to compete in full or undress uniform, and to use cap covers.

ARTICLE 6.-LOCAL COMPETITORS.

1. The Association will annually give a Silver Medal to each County within the Province, to be competed for solely by members of the Association resident in such Counties respectively, and under its Rules, but under the immediate control of the members of the Council resident in such districts respectively, and such other officers as the Council shall appoint.

2. No Medal shall be given to any County unless the names and subscriptions of at least twelve members resident within such County shall be forwarded to the Secretary of the Associa-

tion before the first day of July in each year.
3. In addition to the Silver Medal, the Association will return to every such County one half of the annual subscriptions received therefrom, to be competed for at the same time and subject to the same regulations as the Association Medal.

4. Members of the Council and other officers resident in the several Counties, are requested to exert themselves in obtaining local and private prizes to be competed for at the same time as the Association Medal.
