THEREAS the General Assembly of this Province stands prorogued to Thursday the twenty eighth instant, I have thought fit further to prorogue the said General Assembly, and the same is hereby prorogued accordingly to Thursday the twenty eighth day of March next.

HEREAS the Lieutenaut Governor of Her Majesty's Province of New Brunswick, with the Council and Assembly of the said Province, did, in the months of March and July 1866, pass four Acts, which have been transmitted, entitled as follows, viz :---

No. 3105. An Act to revive and continue Chapter 15, Title 3, of the Revised Statutes, 'Of the Export Duty on Lumber.

No. 3129. An Act relating to the imposition of Duties for raising a Revenue.

No. 3136. An Act to perpetuate the Acts relating to the Export Duty on Lumber.

No. 3149. An Act to amend Chapter 87, of the Revised Statutes, 'Of Regulations for Shipping Seamen at the Port of Saint John.'

And whereas the said Acts have been laid before Her Majesty in Council, together with a Letter to the Lord President of the Council, from the Right Honorable the Earl of Carnarvon, one of Her Majesty's Principal Secretaries of State, recommending that the said Acts should be left to their operation : Her Majesty was thereupon this day pleased, by and with the advice of Her Privy Council, to approve the said recommendation. Whereof the Governor, Lieutenant Governor, or Commander in Chief for the time being, of Her Majesty's Province of New Brunswick, and all other persons whom it may concern, are to take notice and govern themselves accordingly.

(CIRCULAR.)

Downing Street, 11th February, 1867.

SIR,-I transmit to you the copy of a Despatch from the Governor of Mauritius, with a Notice announcing that a Floating Light, to be substituted for the present Shore Lights, will be exhibited at the entrance of the Harbour of Port Louis, on the 24th of May next.

I request that you will cause this Notice to be communicated to the Harbour Authorities of the Ports of the Colonies under your Government.

Mauritius, December 18, 1866.

My LORD,-With reference to the previous Correspondence, noted in the margin,* on the subject of the substitution of a Floating Light at the entrance of the Harbour of Port Louis for the present Shore Lights, I have the honor to forward, for the information of the Board of Trade, the accompanying Copies of a Notice, announcing that the change in question will take effect from the 24th May next, and giving the necessary sailing directions for the guidance of vessels approaching the Port.

Copies of this Notice have been forwarded to the different countries enumerated in the enclosed list, bearing the signature of the Colonial Secretary, and I beg that information may be given to the other Governments mentioned in the accompanying Copy of a Letter from the Harbour Master, dated the 14th instant, as well as to any Departments of Her Majesty's Government whom the matter may concern.

NOTICE.

On the 24th of May, 1867, the Harbour Lights at the Entrance of Port Louis, Mauritius, will be done away with. and a Floating Light at the Bell Buoy Anchorage will be substituted.

The Floating' Light Vessel will be moored a little to the N. Wrd. of the present well known Bell Buoy, with the following bearings :

Extreme of land to the Northward : N. E. b. N. Extreme of land to the Westward : W. S. W.

Flagstaff on Fort George : S. E. 1 S.

Depth of Water: 15 fathoms.
