NOTICE.

THE Commissioners of Her Majesty's Customs do hereby give notice, that the Lords Commissioners of Her Majesty's Treasury have directed that on and after the first day of

January one thousand eight hundred and sixty seven, a duplicate Shipping Bill of all Goods entered or required to be entered in transit, under the transit Regulations now in force, from the United Kingdom to the British Possessions abroad, shall be furnished by the person or persons entering such Goods to the proper Officer of Customs at the Port or Ports in the said Kingdom at which such Goods may be entered for exportation in transit.
