HOUSE OF ASSEMBLY.

The following Bill will be introduced at the next meeting of the Legislature of New Brunswick :-

BE it enacted by the Lieutenant Governor, Legislative Council,

and Assembly,-

1. The Justices of the Peace for the County of Kent, or the major part of them, at any General or Special Sessions of the Peace called for that purpose, to be holden in and for the said County, be and they are hereby authorized and empowered to make a rate and assessment on the Parish of Richibucto, in the said County of Kent, for a sum not exceeding twelve hundred dollars, for defraying the expense of building, erecting and finishing a Wharf at the County ground, in front of the Court House, in the said Parish, for the use of the same, and for the erection of a Warehouse thereon, and to make such regulations concerning the erection of the said Wharf and Warehouse, and the management thereof, as to them may seem meet.
