NEW BRUNSWICK PROVINCIAL RIFLE ASSOCIATION.

THE following particulars relative to the General Competition for 1868, are published for general information :—

FIRST COMPETITION.

Association Gold Medal, and twenty Prizes, value \$200. First Prize, Medal and \$40. Two Ranges-500 and 600 yards-five rounds at each. Open to all members.

SECOND COMPETITION.

National Rifle Association of England Silver Medal, and twenty Prizes, value \$200. First Prize, Medal and \$40. Two Ranges -300 and 500 yards-five rounds at each. Open to all members.

THIRD COMPETITION.

The Ladies' Cup (value \$400,) and twelve Prizes, value \$124. First Prize, Cup and \$30. Two Ranges—500 and 600 yards— seven rounds at each. Open to all members.—The Cup to be the property of the member winning it twice consecutively.

FOURTH COMPETITION.

Prince of Wales' Challenge Cup, Provincial Silver Medal, and twelve Prizes, value \$124. Open to Class A of the Active Militia (Volunteers) only. First Prize to holder of Cup, Silver Medal in the thirty second year of Her Majesty's Reign. and \$30. Three Ranges-200, 300 and 400 yards-five rounds at each.

FIFTH COMPETITION.

Twelve Prizes, value \$124. Open only to Officers of the Militia, Members of the Association, not being Volunteers. First Prize \$30. Three Ranges—200, 300 and 400 yards—five rounds at each.

SIXTH COMPETITION.

Field Officers' Special Subscription Prizes to be competed for under Wimbledon Regulations. Open only to best shots at pre-vious Competitions. (Those who have won Prizes.) Three Ranges—700, 800 and 900 yards. Three rounds at each. First Prize, \$40.

SEVENTH COMPETITION.

The City of Saint John Prize, a Purse of \$50, and other Prizes. Open to all members. Two Ranges-400 and 600 yards-five rounds at each.

EIGHTH COMPETITION.

ALL-COMERS PRIZES .- Twelve Prizes, value \$120. First Prize, \$30. Open to all-comers with any Rifle and position; entrance fee, 50cts. Three Ranges-300, 500 and 600 yards-three rounds at each.

NINTH COMPETITION.

CONSOLATION PRIZES .- Sixteeen Prizes. First Prize, \$20. Two Ranges-200 and 400 yards-Three rounds at each. Open to members who have been competitors but not winners of any Prize.

TENTH COMPETITION.

It is in contemplation of the Committee to offer four Prizes for the highest average Scores made throughout the 1st, 2nd, 3rd, 4th (or 5th), 6th, 7th, and 8th Competitions.
