# Downing Street, 30th November, 1867.

My LORD,-I have the honor to inform Your Lordship that Her Majesty will not be advised to exercise her power of disallowance in respect of the following Acts passed by the Legislature of New Brunswick in June 1867, which were forwarded to me in Major General Doyle's Despatch, dated the 12th ultimo :-

Cap. 2. An Act relating to the Export Duty on Lumber. 3. An Act to provide for defraying certain expenses of the Civil Government of the Province.

4. An Act to provide for the repair and improvement of Roads and Bridges, and other Public Works and Services.
