An Act to amend the Act authorizing the sale of Church Lands in Fredericton.

An Act relating to Water Supply in the City of Saint John and part of the Parish of Portland in the County of Saint John.

An Act to repeal Section, 29, of Part I, Title iv, Chapter 40, of the Revised Statutes, 'Of the Post Office.'
