A PROCLAMATION.

7 HEREAS an Act intituled "An Act relating to the appointment of Justices of the Peace in the several Counties in this Province," passed by the Legislative Council and Assembly at the last Session of the Legislature, was reserved by me on the 21st day of April last for the signification of the Governor General's pleasure;

I do therefore hereby publish and declare that the said Act did receive the assent of the Governor General in

Council on the 20th day of August last.

Given under my Hand and Seal at Fredericton, the twenty second day of September, one thousand eight hundred and sixty nine, and in the thirty third year of Her Majesty's Reign.

amongst other things enacted, that a Bill reserved for the signification of the pleasure of the Governor General, shall not have any force unless and until within one year from the day on which it was presented to the Lieutenant Gov-ernor for the Governor General's assent, the Lieutenant Governor signifies by Speech or Message to each of the Houses of the Legislature, or by Proclamation, that it has received the assent of the Governor General in Council; and whereas on the 21st day of April, 1869, the Lieutenant Governor of the Province of New Brunswick reserved a certain Bill, passed by the Legislative Council and Assembly of the said Province, intituled "A Bill relating to the ap-" pointment of Justices of the Peace in the several Counties "in this Province," for the signification of the Governor General's pleasure thereon; and whereas the said Bill so reserved as aforesaid, has been laid before the Governor General in Council, and it is expedient that the said Bill should be assented to by the Governor General: Now, therefore, the Governor General, in pursuance of the said Act, and in the exercise of the powers thereby reserved to the Governor General as aforesaid, doth, by this present order, by and with the advice of His Privy Council, declare his assent to the said Bill; and the Secretary of State for the Provinces is to give the necessary directions herein accordingly.

An Act relating to the appointment of Justices of the Peace in the several Counties in this Province.

Appointment of Magistrates, by whom made.

3. Magistrate to be sworn before Clerk of the Peace before entering upon duties of office; Clerk to keep a record. Powers, &c. of Magistrate.

5. Former Commissions to 1emain in force.

6. Governor in Council may displace Magistrate.
7. Appointments made since 1st July 1867 to be valid.

BE it enacted by the Lieutenant Governor, Legislative Council, and Assembly, as follows:-

1. It shall be lawful for the Lieutenant Governor, by and with the advice of the Executive Council, at any time or times, to appoint, under the Great Seal of this Province, such and so many Justices of the Peace in and for the several and respective Counties of this Province, and also for the City and County of Saint John, as may be deemed expedient and proper.

2. That in any Commission or Commissions to be issued. it shall be lawful to include the name of one or more person or persons, or to issue a separate Commission to each person

to be appointed.

3. That each person to be appointed, shall, before entering on the duties of his office, be duly sworn before the WHEREAS by an Act passed in the 31st year of Her which he shall be appointed, and such Clerk shall keep a
