COPY OF A REOPRT of a Committee of The Honorable The Privy Council, approved by His Excellency the Governor General in Council on the 17th August, 1869.

The Committee have had under consideration a Memorandum dated 12th August, 1869, from the Honorable the Minister of Justice, having reference to the Imperial "British North America Act, 1867," and to the Order in Council of the 9th June, 1868, on his Memorandum relative to the course to be pursued with respect to the Acts passed by the Provincial Legislatures.

The Minister of Justice reports that he considers the Acts mentioned in the annexed Schedule, passed by the Legislature of the Province of New Brunswick in the fourth Session of the twenty second General Assembly thereof, (being the second Session since the passing of the 'British North America Act 1867,') to be free from objection of any kind. He therefore recommends that the same be respectively left to their operation.

The Committee advise that the Acts mentioned in the said Schedule be respectively left to their operation accord-Certified.
