ANNO TRICESIMO SECUNDO VICTORIÆ REGINÆ.

CAP. I.

An Act to provide for defraying certain expenses of the Civil Government of the Province.

Sec. 1 Amounts granted, to whom. Sec. 2 Amounts, how paid.

Passed 21st April, 1869.

BE it enacted by the Lieutenant Governor, Legislative Council, and Assembly, as follows:—

1. There shall be granted to His Excellency the Lieutenant Governor, the several sums of money hereinafter mentioned, to provide for defraying certain expenses of the Civil Government of the Province:—

A sum not exceeding seven thousand two hundred and seventy dollars, to provide for the Officers and contingent expenses of the Legislature, including Legislative Library and Librarian.

A sum not exceeding five hundred and sixty dollars, to provide for the Clerk of the Crown, Usher of the Supreme Court, Messenger of the Equity Court and Chambers, and Usher of the Court of Divorce.

A sum not exceeding fifteen thousand two hundred and fifty dollars, for certain educational purposes.

A sum not exceeding one thousand dollars, in aid of Immigration during the current year.

A sum not exceeding ten thousand dollars, for Public Printing and Advertising during the current year.

A sum not exceeding eleven thousand dollars, to provide for contingencies, postages, stationery, and telegrams, for the Executive, Legislative, and Public Offices, during the current year.

A sum not exceeding seven thousand dollars, for Surveys, New Roads, and Government Inspections, during the current year.

A sum not exceeding one thousand dollars, to pay for Steam Communication between Shediac and Charlottetown, Prince Edward Island, during the year 1868.

A sum not exceeding three hundred and twenty dollars, to pay Fishery Bounties, (West Isles), for the years 1868 and 1869.

A sum not exceeding eighty nine dollars and ninety one cents, to reimburse Commissioners of Sick and Disabled Seamen, Albert, expenses incurred in the maintenance and support of sick and disabled Seamen, prior to 1867.

A sum not exceeding one hundred and ninety two dollars and nineteen cents, to refund to certain Masters of Vessels, amounts overpaid by them for Hospital Dues at the Port of Saint Andrews, during the years, 1864, 1865, 1866, to 1st July, 1867.

A sum not exceeding one thousand dollars, towards the support of the Saint John Public Hospital.

A sum not exceeding eight hundred dollars, in aid of Wharf at Saint George, in the County of Charlotte.

A sum not exceeding one thousand dollars, in aid of a Steam Boat Wharf at Saint Stephen, in the County of Charlotte.

A sum not exceeding five hundred dollars, to procure seed for distressed Settlers in the County of Carleton.

A sum not exceeding two hundred and seventy six dollars, to refund payments made for Oyster Beds, Shediac.

A sum not exceeding twenty two thousand three hundred and forty dollars and thirty three cents, in aid of the Woodstock Branch Railway.

A sum not exceeding four thousand five hundred dollars, to meet unforeseen expenses during the current year.

A sum not exceeding twenty two thousand four hundred dollars, to defray the current expenses of the Provincial Lunatic Asylum for the current year.

2. The several sums of money aforementioned shall be paid by Warrant or Cheque, out of public moneys now or hereafter in the Receiver General's hands.

CAP. II.

An Act to provide for the repair and improvement of Roads and Bridges, and other Public Works and Services.

Passed 21st April, 1869.

BE it enacted by the Lieutenant Governor, Legislative Council, and Assembly, as follows:—

1. There shall be granted to the Lieutenant Governor, the sum of money hereinafter mentioned, to provide for the improvement of the Roads and Bridges, and other Public Works and Services,—

A sum not exceeding two hundred and four thousand dollars, to provide for the repairs of the Great and Bye Roads of the Province, and for Bridges thereon, for the repairs and maintenance of the Public Buildings, and for Steam Navigation.

2. The said sum of money, and every part thereof, shall be expended under the direction of the Board of Works, and of such Supervisors and Commissioners as the Governor in Council may appoint, and shall be paid to the several and respective persons who shall actually work and labour in making, completing and repairing the several Roads, Bridges, and Works, or in furnishing materials therefor, at the most reasonable rate that such labour and materials can be provided, where such sums are expended on Roads, Bridges, or Works; and every Commissioner so to be appointed shall, as early in the season as may be, carefully examine the part of the Road where any sums of money are to be expended, and shall lay out and mark off such allotment or allotments as may conveniently be contracted for, in order that the making and repairing of the same may be let by auction to the lowest bidder; and in all cases such Commissioners respectively are hereby required to put a sufficient number of notices, not less than ten days previous to such sale, in three or more of the public places of the neighbourhood where the work is to be done, which notices shall specify and describe the work to be performed, and also the place, day and hour when and where the same will be let by auction as aforesaid: and it shall further be the duty of such Commissioners respectively, to attend personally at the time and place so appointed, and there to let out to the lowest
