CAP. LXXXII.

An Act to provide for an Assessment upon that part of the City of Saint John on the eastern side of the Harbour, for special purposes.

1 Corporation authorized to assess.

Sec. 2 Assessment, how applied.

Passed 7th April 1870.

WHEREAS a Judgment has been obtained in the Supreme Court of this Province by Mary Ann Green against the City Corporation of Saint John, for damages sustained by her in passing over the public ferry established in the Harbour of Saint John, and it is necessary to make provision for the payment of the said Judgment, and the interest thereon, and the costs and expenses connected therewith ;---

Be it therefore enacted by the Lieutenant Governor, Legislative Council, and Assembly, as follows :----

1. It shall and may be lawful for the Mayor, Aldermen and Commonalty of the City of Saint John, in Common Council, and they are hereby authorized and empowered and required, in addition to the assessments to be made upon the said City in the present year, to order and direct that an assessment be made and levied upon that part of the City of Saint John lying on the eastern side of the Harbour, and the inhabitants thereof, in such sum and sums of money as may be necessary and required to pay and satisfy the said Judgment obtained by the said Mary Ann Green against the said Mayor, Aldermen and Commonalty of the City of Saint John, and interest payable on said Judgment and all costs, charges and expenses connected with the before mentioned suit, together also with the costs and charges of assessing and collecting the same.

2. The sum and sums of money so levied and assessed shall, when collected, be applied in payment and satisfaction of the said Judgment, and interest thereon, and all costs, charges and expenses of said suit.

An Act to incorporate the President and Directors of the Home for aged Females in the City of Saint John.

year in which his subscription is paid; and any person contributing not less than forty dollars at any one time, shall be a life member thereof; and all members shall be entitled to vote at any general meeting of the Association.

Third-The Association and the Home shall be managed by a Board of Directors to consist of three Gentlemen and six Ladies, and to be elected annually from and by the members on the last Thursday in May; the Directors, when elected, shall at their first meeting appoint from their own members a President, Treasurer, and Secretary, for the year ensuing, and the Directors and officers so elected and appointed, shall continue in office until others are duly elected or appointed in their stead : the Board may fill up its vacancies during any year.

Fourth-The Directors may make such bye laws, rules and regulations as they may from time to time find necessary for the due organization and regulation of the Home, and the admission of inmates thereto, and their conduct while there; but such bye laws, rules and regulations shall be subject to the approval of the Lieutenant Governor in Council.

Fifth-A general meeting may be called at any time by due public notice given by any four of the Directors.

And whereas it is desirable that, for the purposes of the Association, it should be incorporated ;-

Be it therefore enacted by the Lieutenant Governor, Legis-

1. That Beverley Robinson, William Mackay, John Boyd, John W. Nicholson, Jacob V. Troop, William Bayard, Thomas W. Daniel, John V. Thurgar, George Thomas, and Henry W. Frith, their associate members, and successors, are hereby declared to be, and shall be, a body corporate, by the name of "The President and Directors of the Home for aged Females in the City of Saint John," and by such name and style shall have and enjoy perpetual succession, and all the powers and privileges made incident by law to a Corporation in this Province.

2. The Constitution above recited shall be the Constitution of such Corporation, subject to alteration as provided therein, but such alteration shall be also subject to the approval of the Governor in Council.

3. The said Corporation, by the name abovesaid, may receive, hold and eujoy bequests, gifts, donations, and other transfers of real and personal estate, not to exceed in the aggregate in value the sum of four thousand dollars, and may buy, sell, exchange, mortgage or transfer any real estate, acquired or held by it, for the uses and purposes of this Act, as the Directors shall from time to time see fit, for the uses of the said Association.

CAP. LXXXIV.

An Act to incorporate the Saint John Academy of Music Company.

WHEREAS sundry persons in the City and County of Saint John have associated themselves together for the purpose of providing a Home for aged Females in reduced circumstances,

First-The object of this Association is to provide a Home, with board and lodging, for such aged females as the President and Directors hereinafter mentioned shall see fit from time to time to admit.
