ADMIRALTY, August 25, 1870.

SIR,-My Lords Commissioners of the Admiralty having, in concert with the Secretary of State for the Colonies, had under consideration the question of Colonial Bishops being afforded passages in Ships of War, to enable them to visit portions of their Diocese within the limits of the Station under your command, I am commanded by my Lords Commissioners of the Admiralty to acquaint you, that in the case of any Bishop who has hitherto been allowed passages in Ships of War, the practice may be continued where there exist no other facilities for communication.

This is not, however, to be extended to the successors of the present Bishops.

"ORDERED, That all Crown Lands which have been applied for, and on which one or more Instalments have been paid, having Quit claims against them lodged in the Crown Land Office, must be settled for, and Grants taken out, within six months from this date, as after that time the Office will not recognize such claims; and after six months from this date, no Quit claims will be received at that Office."
