

An Act in addition to an Act intituled "An Act to provide for the Election of Councillors and the appointment of Parish Officers in the several Municipalities in this Province."

An Act to compensate Rebecca Cudlip for loss sustained by the taking her lands for the purpose of widening Saint John or Water Street, in the City of Saint John.

An Act to extend the provisions of Chapter 69, Title x, of the Revised Statutes, 'Of Sewers,' to certain Marsh Lands in Sackville.

An Act in further amendment of the Laws relating to Sewerage in the City of Saint John on the Eastern side of the Harbour, and to Sewerage and Water Supply of part of the City of Saint John, and Parish of Portland in the County of Saint John.

An Act further relating to Fences, Trespasses, and Pounds.

An Act to incorporate the Carleton, City of Saint John, Branch Railroad Company.

An Act to remove the Shire Town of King's County to a more convenient locality.

An Act in addition to an Act intituled "An Act to incorporate the Woodstock Railway Company."

An Act to incorporate the New Brunswick Railway Company.

An Act to facilitate the construction of a Railway from Woodstock in the County of Carleton, to the River du Loup.

An Act to provide certain aid for the construction of the Carleton Branch Railway.

An Act to divide the Parish of Saint Stephen, in the County of Charlotte, and to erect a separate District for Ecclesiastical purposes.

An Act relating to the New Brunswick Stave Company.

An Act to exempt the property of Railway Companies from taxation.

An Act to provide for the attendance and examination on oath of Witnesses before the Legislature, or Committees thereof.

An Act to authorize the appointment of a District or Stipendiary Magistrate for the County of Kent.

An Act to incorporate the Saint John Academy of Music Company.

An Act to aid the construction of certain Railway Lines in this Province.

An Act to alter and consolidate the Laws relating to Bastardy and the trial of charges of Bastardy.

An Act to amend an Act made and passed in the thirty second year of the Reign of Her present Majesty, intituled "An Act to authorize the Saint John County Agricultural Society to establish a Market for the sale of Cattle and other live stock."

An Act to erect a part of the Parish of Hampton, in King's County, into a separate Town or Parish.

An Act to repeal thirty second Victoria, Chapter 3, intituled "An Act in amendment of the Act of Assembly twenty fourth Victoria, Chapter 30, relating to the Police Force in the City of Saint John."

An Act for the protection of all persons acting under any Act of the Legislature.

An Act to alter the time for holding the second semi-annual Meeting of the County Council of the Municipality of Sunbury.

An Act to continue and make perpetual an Act intituled "An Act for establishing and maintaining a Police Force in the Parish of Portland, in the City and County of Saint John, and the several Acts in amendment thereof, and for other purposes."

An Act in addition to and in amendment of the Acts relating to County Courts.

An Act relating to the use of Parchment for Public Grants.

An Act to incorporate the New Brunswick Dock Company.

An Act to revive and continue an Act intituled "An Act to authorize the connection of Railway Lines, and to provide for the management and regulation of connecting Lines of Railroads in this Province."

An Act to continue and amend an Act to regulate the sale of Spirituous Liquors.

An Act to incorporate the President and Directors of the Home for the destitute and infirm in the City of Fredericton, in the County of York.

An Act to incorporate the President and Directors of the Home for aged females in the City of Saint John.

An Act to revive and continue an Act made and passed in the twenty seventh year of Her Majesty's Reign, intituled "An Act to incorporate the Albert Railway Company."

An Act to annex a part of the Parish of Dorchester, in the County of Westmorland, to the Parish of Shediack in the same County, for Ecclesiastical purposes.

An Act to authorize the issuing of Debentures on the credit of the Lower District of the Parish of Saint Stephen, in the County of Charlotte.

An Act relating to Imprisonment for Debt.
