

7. The said Corporation is hereby fully authorized and empowered to make, ordain, and enact, and at pleasure to repeal, alter, amend or add to any and all such bye laws as may be found necessary or expedient for the government and conduct of its affairs, whether the same refer to the carrying into effect the object of the said Corporation, the number and names of its officers, the number and places of its meetings, the method of conducting its business, the imposition of fees, fines, dues, or subscriptions upon its members, or to any other matter or thing whatsoever in any way connected with the said Corporation, its business or affairs, provided that no such bye law be repugnant to Law.

8. The first meeting of the said Corporation shall be held at the University, Fredericton, on the evening of Wednesday, the twenty second day of June, in the year of our Lord one thousand eight hundred and seventy, on which day this Act shall come into operation, but not before.

#### CAP. IX.

An Act to amend an Act for establishing and maintaining a Police Force in the Town of Newcastle, in the County of Northumberland.

*Passed 28th March 1870.*

WHEREAS in and by the seventh Section of an Act made and passed in the twenty fifth year of the Reign of Her present Majesty, intituled *An Act for establishing and maintaining a Police Force in the Town of Newcastle, in the County of Northumberland*, the Justices of the said County are authorized to assess the sum of one hundred and fifty pounds, for the purpose of defraying the expenses of supporting and maintaining the said Police Establishment; and whereas the said amount of one hundred and fifty pounds is found to be insufficient for Police purposes, and it is deemed necessary to increase the same;—

Be it therefore enacted by the Lieutenant Governor, Legislative Council, and Assembly, as follows:—

1. That the General Sessions of the Peace in and for the said County of Northumberland, to be holden in January in each and every year, are hereby authorized to make a rate and assessment of a sum not exceeding in any one year the sum of eight hundred dollars, for the purposes of the Act to which this Act is an amendment, and to be levied, collected and applied as directed in and by the said hereinbefore in part recited Act.

2. The General Sessions of the Peace in and for the said County of Northumberland, may at their meeting in the month of July, in the year of our Lord one thousand eight hundred and seventy, make a rate and assessment for the present year, which rate and assessment shall be levied, collected and applied as directed in and by the said hereinbefore in part recited Act.

#### CAP. X.

An Act to alter the Division Line between the Parish of Wicklow and the Parishes of Simonds and Wilmot, in the County of Carleton.

*Passed 28th March 1870.*

BE it enacted by the Lieutenant Governor, Legislative Council, and Assembly,—

That from and after the passing of this Act, instead of the division line between the Parish of Wicklow and the Parishes of Simonds and Wilmot, in the County of Carleton, as heretofore established, the line between the lots number ninety three and ninety four, near the mouth of White Marsh Brook, in the County aforesaid, and the westerly prolongation there-

of, to the American Boundary, shall be the dividing line between the said Parish of Wicklow on the north, and the said Parishes of Simonds and Wilmot respectively on the south, any law to the contrary hereof notwithstanding.

#### CAP. XI.

An Act to alter the Division Line between the Parishes of Saumarez and Inkerman, in the County of Gloucester.

*Passed 28th March 1870.*

BE it enacted by the Lieutenant Governor, Legislative Council, and Assembly,—

That the division line between the Parishes of Saumarez and Inkerman shall, from and after the passing of this Act, be established, deemed and taken to begin on the sea shore, at the northeast angle of the Beach Lot, originally granted to the late Peter and Charles Basterash; thence running in a westerly direction until it strikes the rear line of the Marsh lots, in the bottom of the Tracadie Bay; thence along the said rear line of the said Marshes around the Tracadie Bay or Lagoon, until it strikes the present boundary line at Poulet Brook; thence along the said Poulet Brook to Fair's Bridge; and thence northerly along the present line until it strikes the easterly line of the Parish of Bathurst.

#### CAP. XII.

An Act to amend an Act to erect the Parish of Saint Paul's in the County of Saint John, for Ecclesiastical purposes.

WHEREAS the Building known as the Parish Church of the Parish of Saint Paul's, having become decayed, the Rector, Church Wardens and Vestry of the said Church have removed the same, and have commenced the erection of a new Parish Church upon the site thereof, and have in the mean time completed the erection of a School-house upon a portion of the lands of the said Church vested in the Rector, Church Wardens and Vestry thereof, by an Act made and passed in the nineteenth year of the Reign of Her present Majesty Queen Victoria, intituled *An Act to erect the Parish of Saint Paul's in the County of Saint John, for Ecclesiastical purposes*, which said School-house has been licensed for purposes of public worship, and is now being used for such purposes, pending the completion of the said new Church; and whereas the said Rector, Church Wardens and Vestry of Saint Paul's Church are desirous of making provision for the due election of Church Wardens and Vestrymen, both during the erection and after the completion of the said new Church, and also of carrying out the conditions contained in the original conveyance of the said lands and premises by the late Honorable Ward Chipman to the Rector, Church Wardens and Vestry of Saint Luke's Church, in the Parish of Portland, and County aforesaid, which said lands and premises are now vested in the Rector, Church Wardens and Vestry of Saint Paul's Church as aforesaid, and have agreed to set apart certain sittings in the body of the said new Church to be forever free, in the place and stead of those reserved by the said conveyance in the galleries of the old Church, (it not being contemplated to erect galleries in the said new Church), and have also agreed to make provision for the accommodation of the Choir in a suitable part of the said new Church; and
