have further agreed to make provision for a dwelling for the and being on the said premises granted by the said in part Rector of the said Church in the place and stead of the lands reserved for a Parsonage in and by the said conveyance;-

Be it therefore enacted by the Lieutenant Governor, Legis-

lative Council, and Assembly, as follows:-

1. The said conveyance by the said Honorable Ward Chipman, and the said Act of Assembly made and passed in the nineteenth year of the Reign of Queen Victoria, save and except as the same shall be altered or amended by the terms of this present Act, shall be and remain unaltered and in full force; and, notwithstanding the removal of the said Church or Chapel of Ease, and the erection of such said new Church, or any Church with or without galleries as aforesaid, to be hereafter erected upon the said lands and premises, and all such other matters and things as are hereinbefore recited, shall be good, valid and effectual, and the same are hereby ratified and confirmed.

2. From and after the completion of the said new Church, or so soon as the same may be consecrated or used for public worship, the said Rector, Church Wardens and Vestry of Saint Paul's Church, any thing in the said deed or conveyance to the contrary notwithstanding, shall from time to time set apart and declare to be free and open to all persons, without any rent or price being paid therefor, such and so many of the pews or sittings in the said Church, or any Church to be hereafter erected upon the said premises, being not less at any time than one hundred and fifty sittings, as to the said Rector, Church Wardens and Vestry shall seem meet, in the place and stead of those by the said deed or conveyance reserved in the galleries of the said Church or Chapel now removed; and the residue and remainder only of the said pews or sittings which shall not be so set apart, after providing suitable accommodation in the said Church for the Choir, and also as hereinafter mentioned, shall not be absolutely sold and disposed of, but shall be leased by the said Rector, Church Wardens and Vestry of Saint Paul's Church, for limited times, not exceeding twenty one years, upon such rents and upon such terms and conditions as the said Rector, Church Wardens and Vestry shall from time to time see fit to impose upon and respecting the same.

3. The said Rector, Church Wardens and Vestry of Saint Paul's Church shall set apart and reserve for the use and accommodation of the representatives of the said Honorable Ward Chipman, who may be so entitled under the said deed or conveyance, and for the use and accommodation of the Rector of the said Church for the time being, such and so many sittings as shall give accommodation equal to the square pews reserved by the said deed or conveyance, which said sittings shall be in the place and stead of the square pews by the said deed or conveyance reserved for the purposes therein expressed, and shall not be chargeable with any rent.

4. From and after the consecration for Divine service of the said proposed Church, or any Church to be hereafter erected by the Rector, Church Wardens and Vestry of Saint Paul's Church upon the said premises, the same shall be deemed and taken to be the Parish Church of the said Parish of Saint Paul; and the owners or lessees from the Church Corporation for one year or longer of pews or sittings therein, being males of the age of twenty one years and upwards, (and no others except as hereinafter provided) shall be entitled to all the privileges appertaining to the owners or lessees of pews in the Church or Chapel of Ease heretofore standing

recited Act of Assembly, and shall be subject to the same restrictions as are imposed thereby, except as herein otherwise provided; and in addition thereto, every male person of the age of twenty one years or upwards, who shall be a member of the Church of England, and who shall have been for at least six months of the year preceding the election a stated hearer and attendant at the public worship of the Church of England in the said Parish of Saint Paul, whether the same shall be conducted at the said School House, or such other building in the said Parish of Saint Paul as the said Rector, Church Wardens and Vestry shall from time to time, pending the erection and completion of the said new Church, or of any other new Church to be hereafter erected upon the said premises, determine upon and appoint, or at the said new Church, or any other Church which may hereafter be erected upon the said premises, and who shall have paid to the Rector, Church Wardens and Vestry of the said Church, or to some person authorized by them to receive the same, the sum of ten dollars or upwards in aid of the funds of the said Rector, Church Wardens and Vestry of Saint Paul's Church, for the purposes thereof, for the year preceding the day of election, which sum shall have been paid prior to the day of election, shall be entitled to vote in the choice of Church Wardens and Vestrymen, and shall also be qualified and capable to be elected and chosen a Church Warden or Vestryman of Saint Paul's Church aforesaid; provided always, that no person shall be eligible as a Church Warden or Vestryman unless he shall be a member of the Church of England; and no lessee of any pew or sittings in the said Church, the rent whereof shall be in arrear at the time of any such election, shall be qualified to vote at any such election in respect of the same, or be eligible as a Church Warden or Vestryman.

5. In the meantime and until the consecration of such new Church, the Church Wardens and Vestrymen shall be elected by such persons being males of the age of twenty one years or upwards, and members of the Church of England, as shall have been stated attendants at the School-house where Divine service is now conducted for a period of not less than six months prior to the day of election, and who shall, previous to such day of election, have paid to the said Rector, Church Wardens and Vestry of Saint Paul's Church, or to some person authorized by them to receive the same, the sum of ten dollars or upwards for the year preceding the day of election, in aid of the funds of the said Rector, Church Wardens and Vestry of Saint Paul's Church, for the purposes thereof; provided that no person shall be eligible to be elected a Church Warden or Vestryman except such as shall be qualified to vote at such election as aforesaid.
