THE following is a List of the Acts passed at the recent Session of the Legislature:—

*Passed 1st May 1871.*

An Act relating to the Police Establishment in the City of Fredericton.

An Act in addition to and in amendment of an Act intituled "An Act to incorporate the Carleton (City of Saint John) Branch Railroad Company."

*Passed 17th May 1871.*

An Act to provide for the erection of a Public Wharf at Caraquet, in the County of Gloucester.

An Act to authorize the Roman Catholic Bishop of Chatham to sell and dispose of certain Lands in Richibucto, in the County of Kent.

An Act to amend an Act intituled "An Act to remove the Shire Town of King's County to a more convenient locality," and to establish the Gaols of the Counties of Saint John and Westmorland respectively, as the Gaol of King's County.

An Act in addition to an Act intituled "An Act to erect a part of the Parish of Hampton, in King's County, into a separate Town or Parish."

An Act to enable the Rector, Church Wardens and Vestry of Trinity Church, in the Parish of Saint John, City of Saint John, to dispose of a part of the Burial Ground belonging to them in the Parish of Portland, in the City and County of Saint John.

An Act in amendment of the Act 30th Victoria, Chapter thirty two, intituled "An Act to erect a part of the Parish of Wellington, in the County of Kent, into a separate Town or Parish."

An Act to authorize the Rector, Church Wardens and Vestry of Saint Paul's Church, in the Parish of Saint Paul, in the County of Saint John, to receive and hold gifts and bequests for charitable and pious uses.

An Act in addition to an Act intituled "An Act to incorporate the Houlton Branch Railway Company."

An Act in amendment of an Act intituled "An Act to regulate the sale and disposal of Church and Glebe Lands of the Church of England in this Province."

An Act to amend the Act incorporating the Saint John Academy of Music Company.

An Act to incorporate the Saint Andrews Hotel Company.

An Act to incorporate the Moose Path Driving Park Association.

An Act in amendment of the Act to divide the Parish of Saint Stephen, in the County of Charlotte, and to erect a separate District for Ecclesiastical purposes.

An Act to provide for the erection of a Public Hall in the Parish of Northampton, County of Carleton.
