An Act to authorize and empower the City Council of the City of Fredericton to issue Debentures to the amount of fifty thousand dollars, for the purpose of calling in the present Railway Debentures.

An Act to incorporate the Saint John Real Estate and Building Company.

An Act to incorporate the Miramichi Steam Navigation Company.

An Act to aid in construction of the Victoria Hotel in the City of Saint John.

An Act to authorize the closing up of part of the College Road, in the City of Fredericton, and to open the new Road built along side thereof.

An Act to incorporate the Sackville Cheese Manufacturing Company.

An Act to incorporate the Campo Bello Hotel Company.

An Act to erect part of the Parish of Gordon, in the County of Victoria, into a separate Town or Parish.

An Act to erect a part of the Lake District in the Parish of Harvey, in the County of Albert, into a separate and distinct District.

An Act to regulate the Public Landings in the City and Harbour of Saint John.

An Act in further amendment of the Charter of the City of Saint John.

An Act to establish a Common Field in the Parish of Hillsborough, in the County of Albert.

An Act to regulate the storage of Petroleum and Burning Fluid within the limits of the City of Saint John and Parish of Portland.

An Act to repeal the second Section of an Act passed in the thirty first year of the Reign of Queen Victoria, intituled "An Act to repeal Section 5, Chapter 15, Title iii, of the Revised Statutes, 'Of the Export Duty on Lumber,' and to make provision in lieu thereof."

An Act to incorporate the Saint Martins and Upham Railway Company.

An Act to provide for the more effectually making, improving and repairing of the Highways, Streets and Sidewalks in the Milltown Highway District, in the Parish of Saint Stephen.

An Act to amend an Act intituled "An Act to prevent non-resident Pedlars travelling and selling within this Province without License."

An Act to provide for the establishment of a District at Petitcodiac Station in Salisbury, in the County of Westmorland, and the erection of a Lock-up House therein.

An Act to authorize the erection of a Gate across the Road near the mouth of the Grimross Creek, in Queen's County.
