

An Act in amendment of an Act made and passed in the tenth year of the Reign of Her present Majesty, intituled "An Act for the regulation of Benefit Building Societies," and the Act 29th Victoria, to revive and continue the same.

An Act to establish an additional Circuit Court in and for King's County.

An Act to authorize the Trustees of Saint Andrews Church at Campbellton, in the County of Restigouche, to sell certain Lands, and vest the proceeds in other Lands.

An Act in addition to Title x, of the Revised Statutes, 'Of Commissioners of Sewers.'

An Act to establish a Polling place in the Parish of Canning, in Queen's County.

An Act to enable the County of Victoria to grant aid to the New Brunswick Railway Company.

An Act for the encouragement of Agriculture, and to provide for the establishment of a Provincial Board.

An Act in addition to an Act passed in the thirty third year of the Reign of Her present Majesty, intituled "An Act to continue and amend an Act to regulate the sale of Spirituous Liquors."

An Act to incorporate the Central Railway Company.

An Act to vest in the Roman Catholic Bishop of Saint John, in trust, certain lands and other property, by the last Will and Testament of Catherine Moran devised to the Roman Catholic Poor and Roman Catholic Orphan Asylum.

An Act relating to the Public Wharves in the City of Saint John.

An Act to authorize the Justices of the Peace for the County of Charlotte to erect a Lock-up House at Welchpool, in the Parish of Campo Bello.

An Act in amendment of the Law relating to the General Public Hospital of Saint John, in relation to the annual Accounts thereof, and other Parish and County Accounts."

An Act to amend Chapter 69, of Title x, of the Revised Statutes, 'Of the Commissioners of Sewers for the Parish of Sackville,' for the purpose of dividing District No. 4 into two Districts, and for the election of a Commissioner for the new District.

An Act in addition to and in amendment of the Law relating to the levying and assessing of Rates in the City of Saint John.

An Act to further facilitate the construction of the Albert Railway.

An Act relating to Water Supply in part of the City of Saint John, and Parish of Portland in the County of Saint John; and to reimburse certain persons for Sewers in the City of Saint John.

An Act to enable the Municipality of the County of York to aid in the construction of a Railway from Fredericton to Edmundston.

An Act to transfer certain Church Lands to the Diocesan Church Society.

An Act to facilitate the construction of the Albert Railway.

An Act to provide for defraying certain expenses of the Civil Government of the Province.

An Act to provide for the repair and improvement of Roads and Bridges, and other Public Works and services.

An Act to provide for the expenses of the Legislature.
