within the said Town, or otherwise howsoever:

8th. To regulate the anchorage, lading and unlading of vessels and other crafts arriving in the waters of the said | shouting and other unusual noises in the streets and other Town, as fully as the same might have been theretofore regulated by the General Sessions of the City and County of

9th. To prevent the removal of any stone, gravel, sods, sand or earth from any street, road or highway within the said Town, or the digging or making of any hole in any such street, road or highway, without the licence of the said Coun-

cil, or the Supervisor of Roads of the said Town: 10th. To prevent the incumbering of any street, sidewalk, road or highway within the said Town, and to protect any such street, sidewalk, road or highway from encroachment and injury, and to provide for the confiscation, sale, removal or destruction of every such incumbrance thereon, and to

impose penalties in respect thereof:

11th. To provide for making, paving, flagging, planking and repairing the streets, sidewalks, crossings, roads, or highways, and also for the repairing and good order of the bridges, wharves, docks and slips within the limits of the said Town:

12th. To provide for the removal of all snow and ice from the sidewalks or streets of the said Town, or any part thereof, and to require and compel the owners or occupiers of lands and buildings fronting on or adjoining any such sidewalks or streets, to remove all such snow and ice therefrom:

13th. To provide for the removal of all fences, houses, steps, erections, projections, or obstructions whatsoever, which may now or shall at any time hereafter project into or over any public street, road, sidewalk or highway in the said Town, or any part thereof, which may so project, at the expense of the owners or lessees of the property in or near which such erection, projection or obstruction may be found:

14th. To provide for places of deposit for ashes, cleanings of yards and streets, and other filth and ordure, and to compel the owners or occupiers of property within the said Town to remove all such ashes, cleanings, filth and ordure to such

places of deposit:

15th. To abate and cause to be removed all public nuisances, and all filth and incumbrance on the streets, sidewalks, roads and alleys within the said Town and places adjacent thereto, and to prevent the spreading of contagious or infectious disorders:

16th. To cause vacant lots on recorded streets to be properly enclosed, at the cost and expense of the owners, and to recover such expenses with costs in a summary manner:

17th. To cause lands lying along and below the level of any way, sidewalk, street, or thoroughfare, to be properly enclosed and fenced at the cost and expense of the owners, and to recover such expenses with costs in a summary manner; provided that the said Town shall not be in any way liable for any injuries or damages whatsoever occasioned by the neglect of such owners to erect and maintain any such fence, but the said owners shall be alone liable therefor:

18th. To provide for the security, safety and advantage of the inhabitants, by such rules and regulations and restrictions as they may deem expedient to be observed by all persons in the erection of buildings to be built in the said Town:

19th. To preserve health, peace and good order within

the said Town:

20th. To enforce the due observance of the Sabbath, and to punish vice, immorality or indecency in the streets or other public places within the said Town:

21st. To licence, regulate or prevent billiard tables, bowling alleys, or other places of amusement, and to establish

fees on such licences:

22nd. To restrain or suppress gambling houses, and to enter into them and seize and destroy rouge et noir and roulette tables, and other devices for gambling:

23rd. To restrain and punish all vagrants, drunkards, men-

dicants, and street beggars:

or trades which may be or are likely to become nuisances:

25th. To prevent the ringing of bells, blowing of horns, public places:

26th. To prevent immoderate driving or riding within the

said Town:

27th. To establish bathing houses, and prevent or regulate bathing within or near the said Town:

28th. To establish and regulate one or more pounds, and

the fees to be taken thereat:

29th. To restrain, regulate or prevent the going at large of horses, cattle, swine, goats, sheep, dogs, geese, and poultry, and to impound the same:

30th. To impose penalties on the owners or persons claiming or harboring any such horses, cattle, swine, goats, sheep, dogs, geese and poultry going at large, and to provide for

killing any such goats, geese and poultry:

31st. To impose a tax on the owners or harborers of dogs, and to regulate and prevent dogs running at large, and to provide for killing such as are found so running at large contrary to any bye law made in respect thereof:

32nd. To regulate the Police of the said Town as herein-

after more particularly provided:

33rd. To provide for defraying the expense of lighting the said Town, or any part thereof as shall be deemed necessary, with gas or otherwise, for the purchase and erection of lampposts and lamps where needed, the employment of lamplighters, and all other matters connected therewith, and for compelling the proprietors or occupiers of real property to allow such work to be done, and to permit such fixtures as may be necessary therefor, to be placed in and about their premises at the cost of the said Town:

34th. To provide for numbering the lots or buildings or houses in the said Town, and for affixing the names of the several Streets on any building or erection on or near to the corner of such Street, as they may deem necessary, and for entering upon any dwelling house, property or premises in the said Town, (doing as little damage as need be to the owners and occupiers thereof,) and placing, affixing and making thereon such names or numbers as may be required,

and preventing the removal or defacing thereof:

35th. To establish, regulate and manage a market or markets, and to establish and regulate market days and fairs:

39th. To regulate the measurement of coal, lime, salt, grain, boards, cordwood and other fuel, clapboards, shingles, laths, and other lumber, and to impose penalties for light weight or short count or measurement in any thing marketed:

40th. To regulate the assize of bread, and to provide for the seizure of bread baked contrary thereto, and to impose penalties upon the person so baking contrary to the provisions of any bye laws to be made in that behalf:

41st. To restrain and regulate the purchase of butcher's meat, fish, poultry, vegetables, fruit, country produce, grain, hay, straw, and fodder, and all other articles and things, by 24th.
