ments on the said Town as by law provided, so nearly as they can then determine the same, and in the case of taxes for Town purposes, such estimates shall be used by the Council thereafter elected as the basis of the assessments on the said Town for the said year; but they shall not be bound to the exact amount therein specified if, in their opinion, below or in excess of the sums of money required to be raised.

## WATER COMMISSION.

153. From and after the passing of this Act, on any vacancy occurring in the office of Commissioners of Sewerage and Water Supply for part of the City of Saint John and Parish or Town of Portland, the said Town Council shall have, hold, exercise and enjoy all such right and power of appointment to the same, as are vested in any General or Special Sessions of the Peace for the City and County of Saint John under and by virtue of an Act passed in the eighteenth year of the Reign of Her present Majesty, intituled An Act to provide for an improved system of Sewerage and Water Supply of part of the City of Saint John, and Parish of Portland in the County of Saint John, and any Acts in amendment thereof; and in like manner shall have, hold, exercise and enjoy the right of removal of any such Commissioner appointed by the said Sessions or the said Town Council, and re-appointing in his place, and shall have and exercise all such other rights, powers, duties, privileges and immunities within the said Town of Portland, as to any matter or thing relating to the said Act and Acts of Assembly, as are thereby vested in or given to the said Sessions, or the said Justices for the said City and County.

## COUNTY GAOL.

154. The Gaol of the City and County of Saint John shall be the Gaol of the said Town of Portland, provided that nothing herein contained shall qualify, restrict or alter the provisions of any law whereby prisoners or persons committed or confined under authority of the Police or Sitting Magistrate or Police Court of the Parish or Town of Portland may be confined in the Provincial Penitentiary or the Lock-up House of the said Parish or Town; and notwithstanding the said Gaol and Penitentiary shall be without the limits of the said Town, all warrants, commitments and other processes or proceedings issued or awarded under this Act, whereby any person or persons may be ordered to be committed or confined therein, shall have full power and effect as if the same were within the limits of the said Town, and all keepers and gaolers thereof shall receive all such persons into his and their custody as if the same were within the limits of the said Town, and the authority of the person or persons committing any such person shall extend to such places of confinement, and the conveyance of prisoners thereto through any part of the City and County of Saint John.

155. The Town Council shall have power at any time, by resolution to that effect, to exempt any part of the said Town and of the property therein, and inhabitants thereof, from the operation of any tax for Town purposes levied under authority of this Act, or any part of such tax; and if they shall so determine, then such part of the Town and the property therein, and the inhabitants thereof, shall be so exempted, and the said tax shall in lieu thereof be assessed on the residue of the said Town and the property therein, and the inhabitants thereof.

156. The several Acts and parts of Acts of the General Assembly of New Brunswick mentioned in Schedule B hereto annexed, as also all other Acts and parts of Acts and provisions of Law contrary to or inconsistent with the provisions of this Act, are hereby repealed; provided that such repeal shall not extend to any act, matter or thing done under or by virtue of the said Acts, and the same may, if in part done only, be prosecuted to completion; and every right, liability, privilege and protection in respect thereof, or relating thereto, shall apply and continue to apply as if this Act had not been passed.
