An Act to transfer certain Church Lands to the Diocesan Church Society.

Preamble—Tracts described.  
Schedule of Lots.

Sec. 1 Title, to whom conveyed.  
2 Land to be held in trust.

Passed 17th May 1871.

WHEREAS by Letters Patent under the Great Seal of this Province, bearing date the second day of August, in the year of our Lord one thousand eight hundred and thirty seven, several Tracts or Lots of Land were granted to the Chief Justice, the Archdeacon, the Secretary, the Attorney General and the Solicitor General of this Province for the time being, and their successors in office, in trust, to be conveyed to the Corporations of the Church of England, in the Parishes where the same lie, whenever the same should be legally established as Glebes for the use of the Rectors or Ministers of the said Church in the said Parishes respectively; which said several Tracts of Land are described in the said Letters Patent as follows, that is to say:—

The first Tract being situate in the Parish of Wickham, Queen's County, and bounded as follows, to wit:—Beginning at a stake and stones placed on the southerly side of the Washademoak Lake and at the western angle of Lot number four, granted to John Holder in the Grant to Samuel Parker and others; thence by the magnetic needle south forty five degrees east one hundred and forty seven chains, (of four poles each), or to the rear line of the said Grant; thence south forty degrees west thirty chains and twenty five links, to a reserved road; thence along the said road north forty five degrees west to the said side of the Lake aforesaid, and a marked poplar tree standing thereon; and thence along the bank or shore of said Lake up stream to the place of beginning; being Lots number five and six, containing four hundred and forty acres more or less:

The second Tract being situate in the Parish of Brunswick, Queen's County, and bounded as follows, to-wit:—Beginning at a marked oak tree standing on the north side of the River Washademoak, and at the southeast angle of that part of Lot number twenty one granted to Richard Thorn, in the Grant to Elisha C. Corey and others, which is situate on the north side of the River Washademoak aforesaid; thence north thirty nine chains, or to the rear line of the said Grant; thence east fourteen chains and seventy five links; thence south one hundred and twenty chains, crossing the Washademoak River aforesaid in that distance; thence west fourteen chains and seventy five links; and thence north, again crossing the said River, to the place of beginning; being Lot number twenty two, containing one hundred and seventy six acres more or less:

The third Tract being situate in the southeast tier of the Hanwell Settlement, in the Parish of Kingsclear, York County, and bounded as follows, to-wit:—Beginning at a stake placed on the southerly side of the Hanwell Road, and at the northerly angle of Lot number nine, granted to Anthony Lockwood; thence south forty five degrees east one hundred and sixty six chains; thence north forty five degrees east twenty chains; thence north forty five degrees west one hundred and sixty six chains, to the said side of Hanwell Road aforesaid; and thence along the said road south forty five degrees west to the place of beginning; being Lot number ten, containing three hundred and thirty acres more or less:

The fourth Tract being situate in the second tier of Lots in Green Settlement, in the Parish of Wicklow, Carleton Connty, and bounded as follows, to wit:—Beginning at the southwest angle of a lot granted to John Venning, and on the east side of a reserved road; thence east fifty three chains, or to the rear line of the front lots on the River Saint John; thence south forty one degrees east fourteen chains; thence west sixty three chains, or to the road aforesaid; and thence along the said road north ten chains, to the place of beginning; being Lot number four, containing fifty five acres more or less:

The fifth Tract being situate in the Parish of Andover, Carleton County, and bounded as follows, to wit:—Beginning at a stake placed on the western bank or shore of the River Saint John at the southeast angle of Lot number sixty one, granted to Peter M'Dougald in the Kent Military Grant; thence west one hundred and thirteen chains, or to the rear line of the said Grant; thence south ten degrees east twenty chains and twenty five links; thence east to the said side of the River Saint John aforesaid, and a marked spruce tree standing thereon; and thence along the shore of said River up stream to the place of beginning; being Lots numbers fifty nine and sixty, containing two hundred and twenty acres more or less:

The sixth Tract being in the Parish of Kent, Carleton County, and bounded as follows, to wit:—Beginning at a marked birch tree standing on the northeasterly side of the River Saint John, and at the southerly angle of Lot number twenty, granted to Richard Wharton in the Kent Military Grant; thence east one hundred and fifteen chains, or to the rear line of the said Grant; thence south forty eight degrees east sixteen chains; thence west to the said side of the River Saint John aforesaid, and a marked iron wood tree standing thereon; and thence along the shore of said River up stream to the place of beginning; being Lot number nineteen, containing one hundred and twenty acres more or less:

The seventh Tract being situate in the Parish of Perth, Carleton County, and bounded as follows, to-wit:—Beginning at a marked birch tree standing on the southeasterly side of the River Saint John, and at the northwesterly angle of Lot number forty nine, in the Kent Military Grant; thence east one hundred and five chains, or to the rear line of that Grant; thence north thirty seven degrees east twelve chains; thence west to the said side of the River Saint John aforesaid, and a marked cedar tree standing thereon; and thence along the shore of said River down stream to the place of beginning; being Lot number fifty, containing one hundred and ten acres more or less:

The eighth Tract being situate in the Parish of Perth, Carleton County, and bounded as follows, to-wit:—Beginning at a marked hemlock tree standing on the eastern bank or shore of the River Saint John, and at the northwesterly angle of Lot number seventy granted to Sergeant Thomas Barry, in the Kent Military Grant; thence east one hundred and ten chains; thence south seventy four degrees east seventy five chains; thence north sixteen degrees east fifty four chains; thence north seventy four degrees west fifty chains, or to the rear of the Grant to Joseph M'Connell; thence south five degrees west five chains, or to the southeast angle of the said Grant to Joseph M'Connell; thence west forty chains, or to the Grant to Sergeant Charles M'Lauchlin; thence south twenty chains, to the Grant to Ezekiel Slood; thence east twenty five chains; thence south fifteen chains; thence west to the said side of the River Saint John aforesaid, and a marked hemlock tree standing thereon; and thence along the shore of said River down stream to the place of beginning; being Lot letter H, containing four hundred acres more or less:

The ninth Tract being situate in the Parish of Perth, Carleton County, and bounded as follows, to-wit:—Beginning at a marked hemlock tree standing on the easterly bank or shore of the River Saint John, and at the northwesterly angle of Lot number seventy seven granted to Henry Merritt, in the Kent Military Grant; thence east one hundred and sixteen
