with or prevent the recovery of any assessment which may | have been previously ordered, or with any fines, penalties or money which may accrue or become due, or with the discharge of the duties of any officer who may have been appointed for the year then running, but every such officer shall discharge his duty until the end of the year in the same manner as if the Parish of Gordon had not been divided; and nothing in this Act contained shall be construed to relieve either section of the said Parish hereby divided from their respective liabilities.

4. That the polling place for the said Parish of Lorne shall be and the same is hereby declared to be at or near George Ivys' in the said Parish, for the election of Members to serve in the General Assembly by virtue of an Act made and passed in the eighteenth year of the Reign of Her present Majesty, intituled An Act to regulate the election of Members to serve in the General Assembly; and that the polling place for the Parish of Gordon shall be the same as now established

by law.

5. If any election of Members to serve in the General Assembly for the County of Victoria shall be held before a new Revisors' List shall be made out for the said Parish of Gordon and the Parish of Lorne, the Sheriff shall from the present list select the electors who reside in the Parish of Lorne hereby created, which shall be the list for such last mentioned Parish, who are to vote at the Polling place estab. lished by this Act for the said Parish of Lorne; all other electors who are entitled to vote in the said Parish of Gordon, shall vote at the Polling place heretofore established for the said Parish of Gordon.

CAP. XXX.

An Act to erect a part of the Lake District in the Parish of Harvey in the County of Albert, into a separate and distinct District.

BE it enacted by the Lieutenant Governor, Legislative Council, and Assembly, as follows:-

1. That all that part of the marsh land, bog land, low land, alder land, land covered with water, or other land in the Lake District, in the Parish of Harvey, in the County of Albert, included and known in and by the following boundaries and description, that is to say:-All the said lands bounded on the north and east by Shepody River, from the eastward shore or end of German Town Lake down the River, until it comes to the upland at the red bank, so called, then on the south by the edge or margin of the said upland, in its several courses from where the said River comes to the said upland as aforesaid, westward to the aforesaid shore of the said Lake, and on the west by the eastward shore of the said Lake from the said upland to the said River, be and the same is hereby erected into and constituted a separate and distinct District, to be called and known as the Turner District.

2. That from and after the passing of this Act, the lands within the said Turner District shall not be under the control, or further subject to the jurisdiction of the Commissioners of Sewers heretofore appointed for the said Lake District, or hereafter to be appointed for the remaining or other portion of the said Lake District.

CAP. XXXI.

An Act to regulate the Public Landings in the City and Harbour of Saint John.

1 Additional powers to Mayor, &c.

Constables of Police may arrest

Passed 17th May 1871.

WHEREAS it is desirable to increase the powers of the Common Council of the City of Saint John to regulate the Public Landings in the City of Saint John ;-

Be it therefore enacted by the Lieutenant Governor, Le-

gislative Council, and Assembly, as follows:-

- 1. It shall and may be lawful for the Mayor, Aldermen and Commonalty of the City of Saint John, in Common Council, and they are hereby authorized and empowered, in addition to the powers granted to them by the Charter of the City of Saint John, and the Laws in force relating to said City, to make, establish and ordain laws and ordinances for the regulation of the public wharves, piers, floats and landings in the City and Harbour of Saint John, and any of them, and of the persons resorting thereto, as well the passengers arriving thereat or embarking therefrom, as the coachmen, cartmen, porters, and all other persons whomsoever, either upon or at the said wharves, piers, floats, and landings, as also upon the streets, places and thoroughfares adjoining the same, or any part thereof; and with and under such fines, penalties, forfeitures, and punishments, by imprisonment and otherwise, as the said Common Council may see fit and determine.
- 2. It shall and may be lawful for, and it shall be the duty of the constables of the Police force of the City of Saint John, to take into custody without warrant, any person who in the view of any such constable shall commit, or who any such constable may believe to have committed any offence against the provisions of any such bye law or ordinance, or shall be or have been guilty of any breach of any of the regulations prescribed by any such bye law or ordinence, and on such arrest convey the offender to the Police Office or Station in the City of Saint John, to be dealt with according to law; and every such policeman shall, for the purposes of this Act, and the enforcing of the provisions of any such bye law and ordinance made under the powers of this Act, have all the powers, authorities, and protections, and be in all respects subject to the liabilities and duties conferred and imposed on the constables of the Police force in the City of Saint John, under the Laws relating to the Police force of the said City; and the policemen of the said City shall be at all times vigilant and faithful in enforcing obedience to the provisions and regulations of every such bye law and ordinance.
