NOTICE IS HEREBY GIVEN :

- 1. That Schools conducted under the Act relating to Parish Schools, will close with the repeal of said Act on December 31, 1871; and that Retnrns of the same are to be made to this Office on December 30th.
- 2. That the Act relating to Common Schools comes into operation on January 1, 1872; and that District School Meetings are to be held on January 11th.
- 3. That, for purposes of administration connected with the Act relating to Common Schools, the Board of Education has prescribed :
  - (1) That the School year be divided into two School Terms : the first Term beginning on November 1st, and closing and closing on October 31st.
- (2) That the first Term under the operation of the Act, begin on January 15, 1872, and close on April 30, 1872.
