CAP. XIV.

An Act in amendment of the Act 30th Victoria, Chapter 32, intituled "An Act to erect part of the Parish of Wellington, in the County of Kent, into a separate Town or Parish."

New division line. 2 Part of St. Mary to be included in Parish of Wellington. 3 Assessments in 1871, how levied and collected.

4 In case of election what list shall be used.

Passed 17th May 1871.

WHEREAS the present division line between the Parish of Wellington and the Parish of Saint Mary, as established by the Act 30th Victoria, Chapter 32, is found to be unsuitable and inconvenient;-

Be it therefore enacted by the Lieutenant Governor, Legis lative Council, and Assembly, as follows:-

1. The line dividing the said Parishes shall be as follows. viz:-Commencing at the southeast corner of Lot number

corner of Lot number seven granted to Joshua White; the Little Buctouche River; thence up stream to the line between Lots U and V; thence along said line and its prolongation south forty three degrees east till it intersects the Parish of Dundas.

2. All that part of the Parish erected by the Act 30th Victoria, Chapter 32, and at present known as the Parish of Saint Mary, lying to the east of the said line, shall be included in and become part of the Parish of Wellington.

3. Until the first day of January eighteen hundred and seventy two, all assessments and rates which shall have been made upon the present Parish of Saint Mary previous to the passing of this Act, shall be levied and collected as if this Act had not been passed, nor the division line between the said Parishes altered.

4. If any election shall be held before a new Revisors' List of Electors shall be made out for the said Parish of Saint Mary, as erected by this Act, the electors on the present Revisors' List for the Parish of Saint Mary may vote at the polling place for the said Parish established by the said Act 30th Victoria, Chapter 32, as if this Act had not passed.
