GOVERNMENT NOTICE.

THE following Rules, Orders and Regulations have been made by the Lieutenant Governor in Council, under and by virtue of the Act of Assembly 36th Victoria, Chapter 22, intituled "An Act to provide for Vaccination."

Rules, Orders, and Regulations.

BE it ordained by the Governor in Council as follows:—

1. From and after the 1st day of December, A. D. 1873, it shall be the duty of the Board of Health in any City, Incorporated Town or Parish to which these Regulations may be extended, if there shall be a Board of Health therein established, and if not, then of the Municipal Council of such City or Town, or the General Sessions or Council of the County in which such Parish is situate, as the case may be, to appoint one or more competent medical practitioner or practitioners for the period of one year, and so from year to year, for the vaccination of all persons resident in such City, Town or Parish, who may come to such medical practitioner or practitioners for that purpose.

2. The medical practitioners so chosen shall appoint a convenient place in the City, Town, or Parish, as the case may be, for the performance, at least once in each month, of such vaccination; and the authority appointing shall take effectual means for giving from time to time all persons resident within the same, due notice of the days and hours at which the medical practitioner, or one of the medical practitioners so appointed, will attend, once at the least in each month, at such place, to vaccinate all persons who by these Regulations may be required to be vaccinated, and also may then appear there; and also, of the days and hours at which such medical practitioner will attend at such place to inspect the progress of such vaccination in the persons so vaccinated.

3. From and after the 1st day of January, A. D. 1874, every person in each of the Cities, Towns or Parishes to which these Regulations may be extended, shall become vaccinated for protection against the small pox; unless (1) such person being under the age of eighteen shall already have been successfully vaccinated, and unless (2) such person being of or above the age of eighteen shall have been successfully vaccinated or re-vaccinated after attaining such age.

4. Every householder and every head of a family, and every male person of the age of twenty one years and upwards within such City, Town, or Parish, shall within one month from and after the first day of January, A. D. 1874, file with the Board of Health of such City, Town, or Parish, and in case there is no Board of Health, with the Clerk, Clerk of the Peace or Secretary-Treasurer, as the case may be, a statement of his name, age, occupation, place of residence, stating if in a City or Town, the Ward or Street in which he resides, and the name, age, occupation, place of residence as aforesaid, of each of the persons in his household or family; and shall also therein make a statement of the times when and of the person by whom the process of vaccination had been performed upon the persons named therein.
