14. Any person who may be vaccinated by a person other than a medical practitioner, shall be entitled to receive without fee from a medical practitioner appointed under these Regulations, a certificate according to the Form D in the Schedule hereto, that he appears to have been successfully vaccinated, if upon inspection by such medical practitioner it shall appear that such person has been successfully vaccinated; and no such person who shall be vaccinated in such manner from and after the first day of January, A. D. 1874, shall be deemed to have been successfully vaccinated, unless he shall have obtained such certificate; and it shall be the duty of the medical practitioner giving such certificate to transmit a duplicate thereof to the Board of Health or other authority, as heretofore provided in cases of vaccination by the medical practitioner; and for neglect so to transmit the same, the medical practitioner shall be liable to the like penalties as on failure to transmit such other certificates as last aforesaid.

15. The sum to be paid to any medical practitioner appointed under these Regulations, shall be fixed by the authority appointing him, but shall not be more than thirty cents for every person successfully vaccinated, including all or any of the certificates required by these Regulations.

16. Any medical practitioner other than those appointed under these Regulations, shall be entitled to receive from the person for whom the vaccination shall be performed the sum of fifteen cents for giving the certificate and transmitting the duplicate of the same to the proper authority.

17. The Board of Health, or in case there is no Board of Health, the Municipal Council of the City or Town, or the General Sessions or County Council, as the case may be, shall furnish all blank forms and certificates required to be filed or given hereunder, without any fee or charge, to any persons requiring the same, and such forms and certificates shall alone be used.

18. A certificate signed by the Chairman of the Board of Health, or by the Clerk, Clerk of the Peace, or Secretary-Treasurer, as the case may be, that it does not appear from the records of the office of such Board of Health, Clerk, Clerk of the Peace, or Secretary-Treasurer, as the case may be, that the person named therein has been successfully vaccinated, or revaccinated, or has filed any of the statements by these Regulations required, shall be prima facie evidence in any proceedings hereunder that the person named in such certificate has not been successfully vaccinated or revaccinated as hereby required, or that the person named therein has not filed the statements hereby required, as the case may be.

19. One half of the expense of vaccination by the medical practitioners appointed hereunder shall be paid by warrant out of the Provincial Treasury ; and the remaining one half shall be borne by the City, Town or Parish in which the services are performed.

20. The City or Town Council, as the case may be, shall, upon the request of the Board of Health, if the appointment of the medical practitioner be by such Board, or if not, then without any request, at the time of ordering the other City or Town rates, order the assessing and levying of the sum due to the medical practitioner or practitioners so appointed, and the same shall be assessed, levied and collected at the same time and in the same manner as other City or Town rates.

21. The General Sessions or County Council shall upon like request of the Board of Health of any Parish, or if there is no such Board, without such request, order the assessment of the sum due to the medical practitioner or practitioners so appointed, and the same shall be assessed, levied and collected at the same time and in the same manner as other Parish rates. 22. Every word importing the singular number may extend to several persons or things as well as to one person or thing; and importing the plural number to one person or thing as well as to several persons or things ; and importing the masculine gender to females as well as males, where such construction would not be repugnant to the context 23 The term " medical practitioner" shall mean a person qualified by law to practice medicine or surgery within the Province, or a person who at the time he performed the act in question was so qualified, and shall not extend to any other.

24. These Regulations shall, subject to the proviso hereinafter contained, extend to the following Cities, Incorporated Towns, and Parishes, viz :--

> The City of Saint John ; The City of Fredericton ; The Town of Portland ; The Town of Woodstock ; The Town of Saint Stephen; The Town of Milltown ;

and the Parishes of Saint Andrews, Chatham, Newcastle, Bathurst, Dalhousie, Addington, Shediac, Sackville, Moncton, Richibucto, Caraquet, Wakefield, Madawaska, and also to any other Parish to which the same may from time to time be extended by order of the Governor in Council; provided nevertheless, that the same shall not be held to extend to any such City, Town or Parish as aforesaid, unless such City, Town or Parish, by the Municipal Council of such City or Town, or the Sessions at a General or Special Sessions, or the County Council in Incorporated Counties, adopt the same for such City, Town, or Parish, as the case may be.
