Passed 16th March, 1874.

An Act in further amendment of an Act intituled "An Act for the protection of Moose."

An Act to authorize non-resident Electors of King's County to vote at Rothesay.

An Act to alter and amend the Law relating to Highways within the Parishes of Lancaster, Simonds, and Saint Martins, in the City and County of Saint John.

Passed 31st March, 1874.

An Act to consolidate and amend the Laws relating to the levying, assessing and collecting the Rates and Taxes in the City of Fredericton.

Passed 8th April, 1874.

An Act to provide for the repair and improvement of Roads and Bridges and other Public Works and Services.

An Act to provide for defraying certain expenses of the Civil Government of the Province.

An Act to incorporate the Westfield Hall Company.

An Act to incorporate certain Districts of the Parish of Saint Stephen, in the County of Charlotte, to be known as "The Town of Upper Mills."

An Act to incorporate the Sussex Lime and Plaster Company.

An Act to regulate the Sale and Leasing of Lands held by the Diocesan Church Society of New Brunswick.

An Act for the relief of the Reverend John Denning Pope.

An Act to increase the Capital Stock, and in further amendment of and in addition to the Act to incorporate the South West Boom Company.

An Act to admit of Actions at Law in certain cases by the representatives of Persons whose death may be caused by the wrongful act, neglect or default of another.

An Act to authorize the appointment of a District or Stipendiary Magistrate and for the erection of a Lock-up House at Sussex, in the County of King's.

An Act to establish a Polling place in the Parish of Colborne, in the County of Restigouche.

An Act to incorporate the Saint John Industrial School.

An Act to incorporate the Bay Side Wharf Company.

An Act to establish an additional Polling place in the County of York.

An Act in amendment of an Act to incorporate the Saint Andrew's Curling Club of Saint John.

An Act to vest in Thomas Souther, George A. Worden, and John Wightman, certain Lands in trust, by Deed of Samuel Belyea and Anna Belyea conveyed to John Wightman, John Hagerty, and John M'Dougald.
