

goods so received on board, and in case the same be not paid, the vessel receiving the said goods on board shall be liable to attachment therefor.

8. The owners of the said wharf, or their lessee, may remove all goods landed or kept thereon at any time after the expiration of twenty four hours from such landing or keeping, and convey the same to some store or warehouse, or if lumber, to some convenient place, or if ballast, to any place; and the said owners or their lessee so receiving the same as aforesaid shall have a lien upon the said goods and lumber for all expenses of cartage, storage, wharfage, labour and charges incident thereto, the ballast to be removed at the expense of the owner, master or person in charge of the vessel placing it on the said wharf.

9. Should the said goods or lumber so removed be not claimed, and all the expenses of removal and keeping be not paid within one month from the day of such removal, the same may be sold at public auction, after one week's notice in two or more of the public newspapers published in the City and County of Saint John, the surplus, (if any) after payment of all expenses as aforesaid, to be paid to the owner or consignee of such goods or lumber.

CAP. LXVII.

An Act to authorize the Rector, Church Wardens and Vestry of Trinity Church, in the Parish of Kingston, in the County of King's, to sell and dispose of certain Lands.

WHEREAS it is deemed advisable to sell a certain lot of Land granted to the Rector, Church Wardens and Vestry of Trinity Church, in the Parish of Kingston, in King's County, for School purposes;—

Be it enacted by the Lieutenant Governor, Legislative Council, and Assembly, as follows:—

1. That the Rector, Church Wardens and Vestry of Trinity Church, in the Parish of Kingston, King's County, be and they are hereby authorized and empowered to sell and dispose of the lot of land in the Parish of Kingston, in King's County, granted to the said Rector, Church Wardens and Vestry of Trinity Church, Kingston, King's County, for School purposes, and described as follows—Beginning at the northerly angle of lot number twenty two, granted to Thomas Sumner, northwest of Kennebecasis River, thence running by the magnet of the year eighteen hundred and nine south forty five degrees west fifteen chains of four poles each, or to western line of lot number fourteen, granted to William Underhill, thence along that line north forty five degrees west seventy eight chains and fifty links, thence north forty five degrees east, or to the western bank or shore of Portage Cove, and thence following the several courses thereof up stream in a southeasterly direction to meet the westerly line of the grant to Walter Bates at the head of Portage Cove, thence north fifty eight chains along the western line of said grant to intersect the southern line thereof, thence along the said line east twenty six chains, or to the western bank or shore of the Mill Pond, and thence following the various courses thereof in a southerly direction to the place of beginning, containing two hundred acres, more or less, distinguished as lot number three; provided notice of such sale, specifying the above described lot, and the time and place of such sale, shall be posted on the door of the said

Trinity Church at least three months before the sale, and also published for a like period in the Royal Gazette of this Province, or in one of the weekly newspapers published in the City of Saint John.

2. The proceeds of any such sale may be invested in debentures either of the Dominion of Canada or of the Province of New Brunswick, or in real estate in trust for School purposes as provided by the original grant, or by the third Section of an Act of Assembly made and passed in the twenty second year of the Reign of Her present Majesty, Chapter thirty five.

CAP. LXVIII.

An Act relating to the New Saint Stephen's Church in the City of Saint John, in connexion with the established Church of Scotland in this Province.

WHEREAS in and by the first Section of an Act made and passed in the fourteenth year of Her Majesty's Reign, intituled *An Act to amend an Act relating to Churches erected or to be erected in this Province in connexion with the established Church of Scotland*, it is among other things enacted, that the pew-owners and male communicants shall assemble on the first Wednesday in June in each year, or within ten days thereafter, and then and there, by a plurality of voices of the said pewholders and male communicants aforesaid then present, between the hours of twelve o'clock, noon, and three o'clock in the afternoon, elect and choose any number not exceeding twelve persons, nor less than five as aforesaid, so proprietors of pews as aforesaid, to be Trustees for the purposes of the said Act; and whereas notwithstanding the said Acts, doubts have arisen as to the right of such annual meeting to limit the number of Trustees to less than twelve, and to remove all doubts so far as the New Saint Stephen's Church of the City of Saint John is concerned, and for other purposes; and whereas the said Trustees are possessed of a certain lot of land in the Parish of Saint Martins, County of Saint John, granted to the said Trustees by Letters Patent under the Great Seal of the Province of New Brunswick, dated the twenty third day of May in the year of our Lord one thousand eight hundred and thirty seven; and whereas the said Trustees are desirous of making the said land more available for the benefit and advantage of the said Church, by selling the same and investing the proceeds in such manner as may be deemed most beneficial to the said Saint Stephen's Church;—

Be it therefore enacted by the Lieutenant Governor, Legislative Council, and Assembly, as follows:—

1. That on the assembling of the pewowners and male communicants of the said "The New Saint Stephen's Church in the City of Saint John" at such annual meeting, on the day and at the time aforesaid, such meeting may, if it shall choose so to do, after the appointment of a Chairman and Secretary, declare by resolution what number of Trustees shall be elected for the year then next ensuing, but which number in no case shall exceed twelve, nor be less than five; and the number so declared by the said resolution shall be the number of Trustees to be elected for the year then next ensuing.

2. That this Act shall only apply to the said "The New Saint Stephen's Church in the City of Saint John."
