Act to extend the time for electing the Trustees of Churches in connexion with the established Church of Scotland, shall not be held or construed to apply to the election of Trustees of the said "The New Saint Stephen's Church in the City of Saint John ;" but the election of Trustees of said Church shall be held and conducted under the several provisions of an Act made and passed in the fourteenth year of Her Majesty's Reign, intituled An Act to amend an Act relating to Churches erected or to be erected in this Province in connexion with the established Church of Scotland, except as by this Act amended.

4. That the Trustees of the said "The New Saint Stephen's Church in the City of Saint John," be and they are hereby authorized to sell and dispose of the said lot of land either in one or in separate parcels, by public or private sale, for the best price or prices that they can obtain for the same, and to grant to the purchaser or purchasers thereof, or any part thereof, a good and sufficient title, in fee simple, under the corporate seal and the hands of the Chairman and Secretary of the said Trustees for the time being.

5. That the proceeds of said land, after deducting the necessary expenses of sale and conveyance thereof, or any part thereof, from time to time as the same may be received. shall be applied by the said Trustees and their successors for the use and benefit of the said Church in the City and County of Saint John, as by them or their successors may be deemed most beneficial and advisable, but in conformity with the trusts in the said Grant contained.

CAP. LXIX.

An Act to provide for a Special Assessment on that part of the City of Saint John on the Eastern side of the Harbour, and to amend the Law relating to the Assessment of Rates.

WHEREAS it is necessary that an assessment should be made on the City of Saint John to provide for the repayment of certain moneys to the general revenue fund of the said City, in the sum of five thousand dollars, remaining due as shewn in recital to Act of last Session, thirty sixth Victoria, Chapter fifty one ;-

Be it therefore enacted by the Lieutenant Governor, Legislative Council, and Assembly, as follows :--

1. It shall and may be lawful for the Mayor, Aldermen and Commonalty of the City of Saint John in Common Council, and they are hereby authorized and required within thirty days from and after the passing of this Act in the present year to order and direct an assessment upon that part cf the City of Saint John and the inhabitants thereof on the eastern side of the Harbour, in addition to the yearly assessment for other civic purposes, for the sum of five thousand dollars, besides the costs and expenses of levying and collecting the same, to be assessed, levied and collected at the time of levying and collecting other City rates, and therewith in the same manner as the assessments under the provisions of the "Saint John City Assessment Act of 1859," and the several Acts in force in amendment thereof and in addition thereto.

3. The provisions of an Act made and passed in the thirty | of Saint John for the time being, and shall be by him paid into the general revenue fund of the said City, known as the " East side Fund."

> 3. In case the agent or manager mentioned and referred to in the fourth Section of an Act passed in the thirty first year of the Reign of Her present Majesty, intituled An Act in addition to and in amendment of the Law relating to the loying, assessing and collecting of Rates and Taxes in the City of Saint John, heretofore assessed, or who may hereafter be assessed as such agent or manager, pursuant to the provisions of such Section, shall die, resign, remove from the City of Saint John, or cease to be such agent or manager at any time after any assessment has been made and before the same is collected and paid according to law, it shall and may be lawful for the Assessors of Taxes for the time being to alter the name or names in the Assessment Books or Lists from the name of the agent or manager assessed to the name or names of any person who may for the time being become and be the agent or manager, as the case may be, and the sum and sums so assessed shall be paid by and shall be recoverable from the agent or manager for the time being in like manner and with the like effect as if he had been originally duly assessed as such agent or manager in said Assessment Books or Lists, and no further or other notice shall be necessary.

CAP. LXX.

An Act to authorize a Special Assessment for Streets in the City of Saint John.

Passed 8th April, 1874.

WHEREAS it is necessary to provide an additional sum of money in the present year for the repairing and improving of the Streets in the City of Saint John on the eastern side of the Harbour ;---

Be it enacted by the Lieutenant Governor, Legislative Council, and Assembly, as follows :--

It shall and may be lawful for the Mayor, Aldermen and Commonalty of the City of Saint John in Common Council, within thirty days after the passing of this Act in the present year, in addition to the ordinary yearly assessment for streets, to order and direct an assessment upon that part of the City of Saint John on the eastern side of the Harbour, and the inhabitants thereof, in the sum of ten thousand dollars, to be expended in the making, repairing, altering and improving of the public streets in that part of the said City on the eastern side of the Harbour of Saint John ; the said assessment, together with the costs of levying and collecting the same, to be made, levied and collected in the same manner as and in addition to the ordinary yearly assessment for rates under the provisions of "The Saint John City Assessment Act of 1859," and the several Acts in force in addition thereto and in amendment thereof.

CAP. LXXI.

An Act to authorize a further issue of Carleton Water Scrip in the City of Saint John.

2. The moneys so assessed and collected under this Act shall be paid to and received by the Chamberlain of the City
