the different owners of logs in the said boom in proportion | being published in the Royal Gazette by said Company withto the quantity owned by each.

8. A boom master shall be appointed by the Governor in Council before the tenth day of April in each year, who shall, before entering on the duties of his office, make and subscribe the following oath of office before a Judge of the County Court, or the Mayor of the Town of Woodstock :-

"I, A. B., do solemnly swear that I will faithfully and impartially, to the best of my judgment, superintend the passing of all logs, timber and other lumber through the gap or open space in the main boom of the Meduxnikik Boom Company, and that I will, to the best of my judgment, faithfully and impartially perform all the duties imposed upon me by the Meduxnikik Boom Company Amendment Act.-So help me God."

And the boom master is hereby authorized and required, and it shall be his duty, in addition to the other duties incidental to his employment as boom master, to see that the requirements of this Act are faithfully observed and performed, and to that end he is hereby required, under a penalty of fifty dollars, to be recovered for the benefit of the overseers of the poor for the Parish of Woodstock, before any two Justices of the Peace of Carleton County, upon the information of any aggrieved party, to diligently and impartially discharge the duties imposed upon him by this Act during the running season, or while the logs are being run out of the said boom into the Saint John River; but at no time shall his services be longer required after the logs or other lumber have ceased to be run into the said Saint John River; and no conviction hereunder shall be a bar to further proceedings for a breach of duty occurring after the information laid on which the previous conviction was had.

9. The boom master shall receive compensation for his services at the rate of six dollars per day while he shall be employed, as provided in the eighth Section of this Act; and it shall be lawful for him, in case he is unable from sickness or other good cause, to discharge his duties as boom and it has been discovered that they neglected to make the master, to appoint a Deputy, who shall before a Justice of the Peace make and subscribe the same oath as prescribed for the boom master, and, in the absence of the boom master, shall perform the duties of boom master, and who shall receive the same compensation, perform the same duties, and lative authority;be subject to the same penalty, as the boom master under the provisions of this Act.

10. The said Company shall hold an annual meeting in the month of January in each year, at which annual meeting the stockholders of said Company shall elect a Board of five Associations of New Brunswick, be and they are hereby em-

11. The said Company shall give two weeks' notice of its annual meeting by publishing a notice thereof in the Royal Gazette or in a newspaper published in the County of Carleton (if there be any so published) for two weeks before the time of such meeting, all of which annual meetings shall be open to the public.

in thirty days after each said annual meeting.

13. An Act made and passed in the tenth year of the Reign of Queen Victoria, intituled An Act to amend the Act to incorporate the Meduxnikik Boom Company, be and the same is hereby repealed; and that all Acts or parts of Acts repugnant to or inconsistent with the provisions of this Act, be and the same are hereby repealed in so far as they are inconsistent with or repugnant to the same.

CAP. LXII.

An Act to enable the Trustees of the Baptist Seminary at Fredericton to convey the same.

Passed 8th April, 1874.

WHEREAS the Baptist Educational Society in connexion with the Eastern and Western Baptist Associations of New Brunswick, did, in pursuance of the authority of the Act of Assembly, eighteenth Victoria, Chapter sixty seven, elect a Board of Trustees to manage the affairs of the Baptist Seminary at Fredericton, being the property of the said Society, which Board of Trustees, by the provisions of the said Act, became a body corporate, by the name of "The Trustees of the Baptist Seminary at Fredericton," and which said Corporation has, ever since its organization, been in the possession of and had the management of the affairs of the said Semirary under the direction of the said Educational Society; and whereas by the second Section of the said Act, it is provided that all property held in trust for such Society in any part of the Province, should be subject to the provisions of the said Act whenever a Board of Trustees to manage the same should be elected, as provided in the said Act, and that a conveyance thereof should be made by the then existing Trustees to the said Corporation; and whereas the Trustees existing at the time of the organization of the said Corporation, and by whom the title to the said Seminary and land was held in trust for the said Society, have since died, conveyance thereof to the said Corporation as they were required to do by the said Act, and the difficulty and expense of procuring the title and making a conveyance thereof by the present Corporation would be very great without legis-

Be it therefore enacted by the Lieutenant Governor, Legislative Council, and Assembly,-

That "The Trustees of the Baptist Seminary at Fredericton," in connexion with the Eastern and Western Baptist powered, under the Seal of the said Corporation, to make and execute a good and sufficient deed or conveyance of the said Seminary lands and buildings in connection therewith, to any person or body corporate who may agree for the purchase of the same, which deed or conveyance shall give to the grantee as good a title in law and equity, to all intents and purposes, as if the said Seminary lands and buildings 12. That the names of the President, Secretary and Trea- had been actually conveyed to the said Corporation by the surer of said Company shall be made public, by the same said first named Trustees in the manner provided by the said recited Act.
