An Act to alter the Division line between the Counties of Victoria and Madawaska.

Passed 10th April, 1875.

WHEREAS it is deemed advisable to alter the dividing line between the Counties of Victoria and Madawaska;—

Be it therefore enacted by the Lieutenant Governor, Legislative Council, and Assembly, as follows:—

1. Instead of the dividing line between the Counties of Victoria and Madawaska as now established by law, the following shall, from and after the passing of this Act, be and become the dividing line between the said Counties, namely: Beginning at a post standing on the northern bank or shore of the River Saint John, in the southwestern angle of Lot F at the Grand Falls, granted to the Principal Officers of Her Majesty's Ordnance, and thence running by the magnet north thirteen degrees west five chains and forty links to a post; thence north sixty nine degrees west four chains to a post; thence north twelve degrees west eight chains to a post; thence north fifty two degrees east seventy three chains to a post; thence north seventy eight degrees east one hundred and five chains, or to the western line of Lot number three hundred and one, Ennishone Settlement; thence along that line and its prolongation north nineteen degrees east ninety five chains, or to meet the northwestern line of Lot number three hundred and four in said settlement; thence along that line north fifty four degrees east, to the southeastern line of Lot number four hundred and four, granted to Francis Michaud; thence north nineteen degrees and thirty minutes east, to the southwestern line of the tract surveyed by Deputy Beckwith in 1867, and designated on his plan as Commeau Mountain; thence south seventy degrees and thirty minutes east, to the southern angle of said last mentioned tract; and thence true north to the southwestern line of the County of Restigouche.

2. All that part of the Parish of Drummond, in the County of Victoria, lying to the northward of the said line, shall from and after the passing of this Act, form and become a part of the Parish of Saint Leonard, in the County of Madawaska.

3. Nothing in this Act shall in any way interfere with any election or appointment of officers heretofore made for the said Parishes of Saint Leonard and Drummond respectively, or with any assessment of rates either for County, Town, Parish or School purposes heretofore made on either of the said Parishes, or any part thereof.

Passed 10th April, 1875.

BE it enacted by the Lieutenant Governor, Legislative Council, and Assembly, as follows:—

1. That for the election of Members to serve in the General Assembly, at or near Boney Gougane's in the Acadieville Settlement, in the Parish of Carleton, Kent County, shall be the Polling place for all electors of the said Parish residing in that part of the said Parish which lies to the west of the northerly prolongation of the upper or westerly side line of Lot number one hundred on the north side of the Kouchibouguac River, purchased by A. Tebeault, prolonged until it strikes the County line between the Counties of Kent and Northumberland, and the remainder of the electors of the said Parish shall vote at the Polling place now established by law in the said Parish.

2. All that part of the said Parish included in the Polling District hereby established shall be distinguished as District Number two, and the remaining part of the said Parish shall be distinguished as District number one.

3. In the event of an election being held in and for the said County prior to the register of electors for the said Polling Districts being made up, the Sheriff of Kent shall furnish the presiding officers of said Polling Districts respectively with a list of the electors qualified to vote in the said Parish according to the register of electors for the said Parish now filed, residing in the District for which such presiding officer may be appointed, and the said lists shall serve the same purpose and be used in the same way as the copy of the register of electors required to be furnished to the presiding officers by the twenty ninth Section of an Act passed in the eighteenth year of Her Majesty's Reign, intituled *An Act to regulate the Election of Members to serve in the General Assembly*.

Passed 10th April, 1875.

BE it enacted by the Lieutenant Governor, Legislative Council, and Assembly, as follows:—

1. From and after the passing of this Act, the Polling place for the election of Members to serve in the General Assembly for the Parish of West Isles, in the County of Charlotte, shall be at or near the School House in the Burr Island Settlement in the said Parish, instead of at or near the School house in Chocolate Cove.

2. From and after the passing of this Act, the Polling place for the election of such Members for the Parish of Clarendon in the said County, shall be at or near the present residence of John Scott in said Parish, instead of at or near the house of John M. Cutcheon.

3. That for the election of such Members at or near the School House at Wilson's Beach in the Parish of Campo Bello, in the said County, shall be the Polling place for all the electors of the said Parish residing in that part of the Parish of Campo Bello, in the County of Charlotte, described as follows:—Beginning on the shore on the Island of Campo Bello, in Harbour de Lute, at the southwesterly corner of a lot of land now owned by William Galligan; thence in a straight line easterly to the mouth of Schooner Cove Brook; thence northerly, westerly and southerly around the shore of
