the said Island to the place of beginning, including all the Islands in the said Parish to the northward and westward of the said Island of Campo Bello; and the Polling place now by law established, shall be the Polling place for all electors for the said Parish of Campo Bello not resident in the District above described.

4. That in the event of an election being held in and for the said County prior to the register of electors being made up for the two Polling Districts in the said Parish hereby established, the Sheriff of the said County shall from the list of electors now on file in the Office of the Clerk of the Peace for the said County, make up for each of the Polling Districts hereby established a list of the electors resident therein, and file the same in the Office of the Clerk of the Peace; and such last mentioned lists shall be the lists of electors for the said Polling Districts respectively; and a copy of such last mentioned lists respectively shall be furnished to the presiding officers of the said Polling Districts respectively, and shall serve the same purpose and be used in the same way as the copy of the register of electors required to be furnished to presiding officers by the twenty ninth Section of an Act passed in the eighteenth year of Her Majesty's Reign, intituled An Act to regulate the Election of Members to serve in the General Assembly.

BE it enacted by the Lieutenant Governor, Legislative Council, and Assembly, as follows:—

1. That for the election of Members to serve in the General Assembly, at or near Thomas Caie's at Trout Brook, in the Parish of Weldford, in the County of Kent, shall be the Polling place for all electors of the said Parish residing north of the Richibucto River and south of the Road leading from Caie's Bridge to James Thompson's on the Harley Road, and the prolongation of such Road west to the Parish line, and residing south of the said Richibucto River, west of Bell's Creek, so called, and a line drawn from its mouth to the M'Laughlan Road, and thence along the M'Laughlan Road to the Parish line; and the remainder of the electors of the said Parish, residing south of the Richibucto River, shall vote at the place now established by law, at or near the West Branch Bridge; and the remainder of the electors of the said Parish, residing north of the said Richibucto River, shall vote at the place now established by law, at or near Molan's River Bridge.

2. In the event of an Election being held in and for the said County prior to the register of electors being made for the several Polling Districts as hereby established, the Sheriff shall furnish the presiding officers of said Polling Districts respectively with a list of the electors qualified to vote in the said Parish, according to the several registers of electors of the said Parish, now filed, residing in the district for which such presiding officer may be appointed, and the said lists shall serve the same purpose, and be used in the same way, as the copy of the register of electors required to be furnished to the presiding officers by the twenty ninth Section of an Act passed in the eighteenth year of Her Majesty's Reign, intituled An Act to regulate the Election of Members to serve in the General Assembly.

BE it enacted by the Lieutenant Governor, Legislative Council, and Assembly, as follows:—

- 1. That for the election of Members to serve in the General Assembly, at or near the School House in the Blaney Ridge, in the Parish of Prince William, in the County of York, shall be the Polling place for all electors of the said Parish residing in that part of the said Parish which lies to the southwest of the Pokiok River and the southwest of Lake George; and the remainder of the electors of the said Parish shall vote at the Polling place now established by law in the said Parish.
- 2. All that part of the said Parish included in the new Polling District hereby established, shall be distinguished as District Number One, and the other part of the said Parish shall be distinguished as District Number Two.
- 3. That for the election of Members to serve in the General Assembly, at or near Millville Station, in the Parish of Southampton in the said County, shall be the Polling place for all electors of District Number Two of the said Parish, residing in that part of the said District lying northeast of the southwestern line of Lot number sixteen in Maple Ridge, and its southeasterly prolongation to the northeast branch of the Nackawicac, bounded westerly by the main northwest branch of Nackawicac and Fall Brook, easterly by the northeast branch of the Nackawicac, and northeasterly by the southwestern line of the Parish of Bright, and the remainder of the electors of the said District shall vote at the Polling place now established by law in the said District.
- 4. All that part of the said District hereby included in the new District, shall be known as District Number Three, and the remainder of the said District shall be known as District Number Two.
- 5. In the event of an election being held in and for the said County for Members or a Member to serve in the General Assembly, prior to the registers of electors for the said Polling Districts hereby established being made up, the Sheriff of York shall furnish the presiding officers of said Polling Districts respectively, with a list of the electors qualified to vote in the said Parishes respectively, according to the register or registers of electors for the said Parishes now filed, residing in the District for which such presiding officer may be appointed; and the said lists shall serve the same purpose, and be used in the same way, as the copy of the register of electors required to be furnished to the presiding officers by the twenty ninth Section of an Act passed in the eighteenth year of Her Majesty's Reign, intituled An Act to regulate the Election of Members to serve in the General Assembly.
- 6. That for the election of Members to serve in the General Assembly, at or near the Forks of the Road below Abraham Brewer's mill in Lower Haynesville, in the Parish of Bright in the said County, shall be the Polling place for electors residing in District Number Two in said Parish of Bright, instead of at or near Adonijah Morehouse's, as heretofore established by law.
