BE it enacted by the Lieutenant Governor, Legislative Council, and Assembly, as follows :--

1. That for the election of Members to serve in the General Assembly, at or near the School Honse near Trout Brook on the Chaplain Island road, in the Parish of Northesk, in the County of Northumberland, shall be the Polling place for all electors of the said Parish residing to the northward of a line commencing where the said Chaplain Island road intersects the division line between the Parishes of Northesk and Newcastle; thence in a westerly direction to the mouth of the Big Sevogle River; and thence produced westerly to the County line; and the remainder of the electors for the said Parish shall vote at the Polling places now established by law in the said Parish.

1. In the event of an Election being held in and for the said County prior to the registers of electors for the several Polling Districts in the said Parish being made up, the Sheriff shall furnish the presiding officers of the said Polling Districts respectively, with a list of the electors qualified to vote in the said Parish, according to the registers of electors for the said Parish now filed, residing in the District for which such presiding officer may be appointed; and the said lists shall serve the same purpose and be used in the same way as the copy of the register of electors required to be furnished to the presiding officers by the twenty ninth Section of an Act passed in the eighteenth year of Her Majesty's Reign, intituled An Act to regulate the Election of Members to serve in the General Assembly.

3. That the Polling booth for the District in the Parish of Alnwick, in the said County, known as Alnwick No. 2, shall hereafter be established and held at or near the Bridge over the Burnt Church River, in the New Jersey Settlement in the said Parish, instead of at Lower Neguac.

CAP. CVII.

An Act to alter the Polling place in the Parish of Petersville, Queen's County.

Sec. 1 Polling place changed. Sec. 2 Part of former Act repealed.

Passed 10th April, 1875.

BE it enacted by the Lieutenant Governor, Legislative Council, and Assembly, as follows :--

1. The following shall be a Polling place in Queen's County for the election of Members to serve in the General Assembly, in addition to those already established by law, that is to say,—At or near Armstrong's Corner, so called, in the Parish of Petersville. and to vest in the Commissioners hereby incorporated certain lands and premises devised in Trust by the late Isabella Grundy to the Overseers of the Poor of the City of Saint John.

WHEREAS by the Certificate of the Registrar of Deeds for the time being of the City and County of Saint John, it appears that on the twenty eighth day of July in the year of our Lord one thousand eight hundred and fifty two, there was duly registered in Book T, No. 3, of Records of the said City and County, pages 491, 492, 493, 494, and 495, a certain Indenture in the words and figures following, that is to say:

"This Indenture made the second day of June in the year of our Lord one thousand eight hundred and forty six, between George Matthew of the City of Saint John, in the Province of New Brunswick, yeoman, Gilbert T. Ray of the same place, sail maker, and Walter Drake of the same place, yeoman, of the first part, and John Kerr and Walker Tisdale of the same place, Esquires, George A. Lockhart, at present of Horton, in the Province of Nova Scotia, Esquire, Gehardus Clowes Carman of the Parish Lancaster, County of Saint John, and Province of New Brunswick, Esquire, James Dunn of the Parish of Simonds, in the County and Province aforesaid, yeoman, James Moran of the Parish of Saint Martins, in the County and Province aforesaid, Esquire, and James Gallagher of the Parish of Portland, County and Province aforesaid, Esquire, of the second part;

"Whereas one Isabella Grundy, late of the City of Saint John, in the Province aforesaid, Widow, in and by her last Will and Testament bearing date the fifteenth day of April in the year of our Lord one thousand eight hundred and thirty seven, after devising the dwelling house, land and premises situate in Duke Street in the City of Saint John, in which the said Isabella Grundy then resided, to Mary Hollandlane, wife of William Hollandlane, with whom she, the said Isabella Grundy, had lived a long time, as in the said Will is mentioned, the said Isabella Grundy did thereby give and bequeath all the rest, residue and remainder of her estate, both real and personal, after the payment of ker just debts and funeral expenses, to the Overseers of the Poor of the City of Saint John for the time being;

"And whereas the said parties of the first part were the lawfully appointed Overseers of the Poor for the City of Saint John at the time of the death of the said Isabella Grundy, which happened on or about the twentieth day of April in the year of our Lord one thousand eight hundred and thirty seven;

"And whereas it appears that the said Isabella Grundy died seized of or otherwise entitled to in possession, reversion, or otherwise, certain lands and tenements situate in the City of Saint John aforesaid, and known and described as follows, that is to say :—All that certain lot, piece and parcel of ground then under lease to Solomon Brice, now also deceased, situate in Queen's Ward in Duke Screet in the said City, being thirty six feet off the west side of Lot number eight hundred and seven, and to extend back, containing the same breadth, one hundred feet more or less, together with the common use of the alley or east side of the same piece of ground; and also a certain other lot, piece and parcel of ground situate in the City aforesaid in Germain Street, and then under lease to one Thomas Hay, now deceased,

2. So much of an Act made and passed in the eighteenth year of the Reign of Her present Majesty, intituled An Act to regulate the Election of Members to serve in the General Assembly, as establishes a Polling place at or near Government House, so called, in the Parish of Petersville, is hereby repealed.
