A PROCLAMATION.

HEREAS by an Act made and passed in the thirty eighth year of the Reign of Her present Majesty. intituled "An Act to incorporate the Town of Moncton," it was amongst other things enacted that the said Act should not be in force until it should be determined by a vote of three-fifths of the Electors qualified to vote under the seventy third Section of the above recited Act, that they desire that the said Act should be accepted; And whereas for the purpose of arriving at such determination, the Sheriff of the County of Westmorland was directed to hold a meeting of the said electors, in the manner in the said Act provided; and if three-fifths of the Electors voting at such meeting should be found in the affirmative, he should immediately certify the same to the Lieutenant Governor, and the said Lieutenant Governor should thereupon publish in the Royal Gazette notice that the said Act should from thenceforth be in full force and effect;

And whereas the Sheriff of the said County of Westmorland has certified to the Lieutenant Governor, that he did on the fourteenth day of May instant, after due notice given, hold a Poll within the Town of Moncton, and did take the votes of the Electors qualified to vote as provided by the said Act, and that the persons voting in the affirmative to accept the said Act of Incorporation were more than threefifths of the said Electors voting at such Poll:

Now, therefore, I do hereby in and by virtue of the said Act of Assembly, proclaim and declare, and hereby give notice, that the said Act of Assembly intituled "An Act to incorporate the Town of Moncton," is, and from henceforth shall be, in full force and effect.

Given under my Hand and Seal at Fredericton, the 381 twenty sixth day of May, in the year of our Lord 382 Vitale Duguay, 100 acres, lot 8 south, one thousand eight hundred and seventy five, and in the thirty eighth year of Her Majesty's Reign.
