THE attention of Locatees under the Free Grants Act 1872, and the Act to facilitate the settlement of Crown Lands, "The Labour Act," so called, is especially directed to the following:

SECTION 10, FREE GRANTS ACT 1872.

All trees growing or being upon any lots so assigned as aforesaid, shall be considered as reserved from the said location, and shall be the property of Her Majesty, except that the Locatee, or those claiming under him, may cut and use such timber as may be necessary for the purpose of building, fencing, or fuel,
