LEGISLATIVE COUNCIL CHAMBER,

FREDERICTON, 5th SEPTEMBER, 1877.

THIS day, at eleven o'clock, His Honor The Honorable SAMUEL LEONARD TILLEY, C. B., Lieutenant Governor of the Province of New Brunswick, came to the Council Chamber, and being seated on the Throne, commanded the attendance of the House of Assembly, who being come, His Honor, after assenting to the several Bills passed during the Session, was pleased to close the Session with the following

SPEECH:

" Mr. President, and Honorable Gentlemen of the Legislative Council, " Mr. Speaker, and Gentlemen of the House of Assembly,

"I have pleasure in relieving you from further attendance upon your legislative duties.

"I trust that the several important Acts relating to the City of Saint John, to which I have just given my assent, may conduce to its material advantage."

His Honor then, through the Honorable the President of the Legislative Council, declared the General Assembly prorogued to the second Tuesday in October next.
