A PROCLAMATION.

TT having pleased Almighty GOD in His great mercy to crown the labors of the Husbandman with an abundant Harvest, and to bestow upon the People of this Province manifold and great blessings during the current year ;

I do therefore appoint THURSDAY the twenty first day of November instant, as a Day of Thanksgiving, and recommend the general observance thereof throughout the Province;
