The Tenders in each case must contain the actual signature of two responsible persons willing to become Sureties for the faithful performance of the Contract—otherwise the Tender will not be considered; and the Committee reserve the right to prescribe other provisions for the due completion of each Contract.

The Committee shall not be bound to accept the lowest or any Tender.

In case of the adoption of any Tender for Reporting the Debates, it shall be subject to the approval of the Assembly, and upon such approval, no allowance will be paid by the Government to any other person than the Contractor for the said service.
