respective ships; provided always, that if any such deserter has committed any crime in Her Majesty's dominions, he may be detained until he has been tried by a competent Court, and until his sentence (if any) has been fully carried into effect.

And the Right Honorable the Lords Commissioners of Her Majesty's Treasury and the Secretary of State for India in Council are to give the necessary directions herein accordingly. EDMUND HARRISON

Sir,-Referring to your letter of the 8th November 1877, I am directed to inform you that the Senate of the University of London have acceded to the request of the Governor General of Canada, as regards the holding in Canada of University Examinations subsequent to the Matriculation Examinations, but deem it requisite to limit this concession to the Examinations for Degrees in the Faculties of Arts and Laws.

In order that this scheme may be carried into effect, it will be requisite that the Senate should be informed not later than the 1st of May in each year, at what centres in the Dominion Candidates will present themselves for the ensuing First and Second Examinations for Degrees in Arts, and before the 1st of October in each year, at what centres Candidates will present themselves for the ensuing First aed Second Examinations foe Degrees in Laws. The requisite number of papers for these Examinations, addressed to the several centres named, will then be forwarded to the Colonial Office, on the understanding (as in the case of the Matriculation Examination) that due provision will be made by the local Governments for the conduct of the Examination, and that the answers of the Candidates will be returned through the Colonial Office with as little delay as I am, &c. possible.
