HIS EXCELLENCY THE GOVERNOR GENERAL has received the following telegraphic despatch from the Right Honorable the Secretary of State for the Colonies, dated London, 17th December, 1878:—

"The Court will go into mourning for HER ROYAL HIGHNESS THE GRAND DUCHESS OF HESSE-DARMSTADT, from December 18th, 1878, to January 10th, 1879. General mourning will extend for three weeks from the 15th instant."

In consequence of the above intelligence there will be no receptions at Government House till after the 10th of January, 1879, and the Governor General—as in the case of the mourning for the late Prince Consort—would invite all persons to join in the general mourning.
