## A PROCLAMATION.

Wherefore, your Petitioners humbly pray that Your Excellency will be pleased, by an Order in Council under the ninety sixth Section of the said Act, to declare that the second part of the said Act shall be in force and take effect in the said City. And your Petitioners will ever pray. And that we desire that the votes of all the Electors of the said City be taken for and against the adoption of the said Petition.

And whereas it appears by evidence to the satisfaction of the Governor General in Council that such notice has appended to it the genuine signatures of one fourth or more of all the Electors of the City of Fredericton, N. B., the number of the signature of the city of two hundred and forty three and the tures to the notice being two hundred and forty three, and that the other requirements of the law have been observed;

And whereas an Order of the Governor in Council has been passed directing that the votes of all the Electors of the said City of Fredericton be taken for and against the adoption of the said Petition,

Now Know YE, that We do hereby, and by virtue of the authority vested in Us by the said Act and Order in Council, pro-claim and declare, that on the thirty first day of October instant a Poll will be held in the City of Fredericton for taking the votes of the Electors for and against the said Petition. That such votes will be taken between the hours of nine o'clock in the forenoon and five o'clock in the afternoon of that day, and by ballot. That the Sheriff of the County of York, in the Province of New Brunswick, has been appointed the Returning Officer for the purpose of taking on that day the votes of the Electors for and against the Petition, and of afterwards summing up the same and making a return of the result to the Governor General in Council. That the said Returning Officer is empowered and required to appoint a Deputy Returning Officer at and for each Polling place or station. That the Returning Officer will appoint persons to attend at the various Polling stations, and at the final summing up of votes on behalf of the persons interested in and promoting or opposing respectively, the adoption of the Petition, at the Sheriff's Office in the City of Fredericton, on

the twenty ninth day of October instant, at noon.

That the votes of the electors will be summed up and the result of the polling declared by the Returning Officer at the office of the said Sheriff on the second day of November next at noon. And in the event of the petition being adopted by the electors the Governor General in Council may at any time after the expiration of sixty days from the day on which the same was adopted by Order in Council published in the Canada Gazette declare that the second part of the said Act shall be in force and take effect in such City upon, from and after the day on which the annual or semi-annual licenses for the sale of spirituous liquors then in force in such City will expire, provided such day be not less than ninety days from the day of the date of such Order in Council, and if it be less then on the like day

in the following year.
