if the Federal Government shall determine to assist so important a work by the granting of a reasonable subsidy in its aid.

"Bills relating to the Administration of Justice in the Trial of Causes in the Supreme Court,-to County Valuations for the purposes of Assessment,-and in further amendment of the Law relating to the issue of Provincial Debentures, and other Measures of importance, will be submitted for your consideration.

" Mr. Speaker, and Gentlemen of the House of Assembly,

"I have given directions that the Accounts of the Receipts and Expenditures of the past fiscal year, and a Detailed Statement of the Receipts and Payments of the current year up to the opening of the present Session, and the Estimates for the ensuing year, be laid before you at an early day.

" You will be asked to make provision for the commencement of the erection of additional

accommodation in connection with the Provincial Lunatic Asylum.

" Mr. President, and Honorable Gentlemen of the Legislative Council, " Mr. Speaker, and Gentlemen of the House of Assembly,

"Relying upon your patriotism and zeal in the public service, and commending your deliberations to Divine guidance, I leave you to the performance of your respective duties."
